ORDER:

Kind attention of the Regional Joint Directors of Technical Education, all the Principals and DDOs of Government Polytechnics to the Government Order cited under ref (1) wherein it is stated in para 4(vi) related to increments in AICTE Pay Scales-2006 as follows:

The number of additional increment(s) on placement of each higher stage of AGP may be as per the existing Schemes, Regulations of Increment on promotion from lower Pay Scale to higher Pay Scale, however, in view of the considerable raise in effective pay between the two Pay Bands, there may be no additional increment on movement from the Pay Band of Rs.15600-39100 to the Pay Band of Rs.37400-67000.

Further the Government has issued orders vide ref (3) cited as per 3.9 of Annexure-II of AICTE Notification dated 04.01.2016 as follows:

Head of the Department (HOD)/ Lecturer (Selection Grade), Completing 3 years of service in AGP of Rs. 9000 and possessing a Ph.D. Degree in the relevant discipline shall be eligible, subject to other conditions of academic performance as laid down by the AICTE, shall be placed in Rs.37400-67000 with AGP of Rs.10000.

Hence all the Regional Joint Directors of Technical Education, Principals & DDOs are informed that the Teaching staff who have been placed in the higher AGP of Rs. 10000/- from AGP of Rs. 9000/- on completion of (3) years of service in AGP Rs. 9000 in the cadre of Lecturer (Selection Grade) / Head of Section as the case may be, with Ph.D. qualification in the relevant discipline are eligible for one additional increment from the date of eligibility. The date of eligibility may be the date of completion of (3) years of service in AGP Rs. 9000 if he/she possessed with Ph.D. qualification in the cadre of Lecturer (Selection Grade) / Head of Sections or the date of acquiring the Ph.D. if he/she completes of (3) years of service in AGP Rs. 9000/- in the cadre of Lecturer (Selection Grade) / Head of Sections.

The Regional Joint Directors of Technical Education are hereby delegated powers to sanction one additional increment to all the staff drawing AICTE Pay Scales-2006 under his jurisdiction who have been placed in the higher AGP of Rs. 10000/- from AGP of Rs. 9000/- on completion of (3) years of service in AGP Rs. 9000/- in the cadre of Lecturer (Selection Grade) / Head of Section.
