## Chapter-2 of APH-2024-27:

The existing Institution seeking approval for a Change in the Name of the Institution or affiliating University/ Board or Type of Institution (Institution(s) converted into a University) shall apply on AICTE Web-Portal along with the relevant documents as per Annexure-2 of the Approval Process Handbook.

AICTE gives approval to Institutions based on the norms / standards prescribed by the Council from time to time. To get permission from State Government/ Affiliating University /Board is the sole responsibility of the Institution.

  - No Objection Certificate from affiliating University/ Board Change in the Name of the Course(s)/ Merger of the Courses/ Reduction in Intake/ Closure of Programme(s)/Course(s)
- B. Documents to be submitted at the time of Scrutiny Committee for approval of Change in the Name of the Institution:
  - No Objection Certificate from affiliating University/ Board in Format 2 or A receipt with the Official Seal from the authorized signatory of the affiliating University/ Board as proof of submission of these documents
  - Resolution of the Trust/Society/Company approving the Institution for Change in the Name of the Institution/ duly signed by the Chairman/ Secretary in Format 3.
