## ORDER:

As per the request of Women Development, Child Welfare \& DW Department to the Government, in the reference first read above, the CTE has furnished a proposal for starting of three (3) year Diploma courses as additional setions with an intake of (30) in each course for hearing and speech impaired students in the existing (3) Government Polytechnics i.e., at (1) Andhra Polytechnic, Kakinada with Diploma in Architecture Course (2) Government Polytechnic, Warangal with Diploma in Computer Engineering Course and (3) Government Institute of Electronics, Secunderabad with Diploma in Electronics and Communication Engineering course from the academic year 2012-2013, and also furnished the proposal for sanction of posts along with the financial implications. The Commissioner of technical Education has further stated that the Commissioner, Welfare for Disabled and Senior Citizens Department, Hyderabad has agreed in principle to provide infrastructure equipment, assistive devices like group hearing aids, individual hearing aids etc., and informed that hostel facility will be provided by them. Hence, the CTE has requested the Government to examine the proposal and issue necessary orders in the matter.
2. Government after careful examination of the proposal of the Commissioner of Technical Education, A.P., Hyderabad in the reference read above, hereby sanction three-year Diploma Courses as additional sections for Hearing and Speech Impaired students duly creating the required Regular Posts in the existing three (3) Government Polytechnics from the academic year 2014-15 as follows:-
