In this connection, the School Education, Collegiate and Technical Education Departments are requested to issue instructions to all the Educational Institutions in the State/Private Sector under their control for observance of **two minutes silence at 11.00 hours on 30-01-2014 (THURSDAY)**, in memory of those who gave their lives in the struggle for India's freedom.
