Sub : Technical Education – Assessment of Industrial Training for 6 months during 6th semester- Bifurcation of 6th semester for undergoing the 6 months industrial training for Old/New Polytechnics established and admissions approved for the Academic year 2012-13 and also for additional courses, increasing the intake for the Academic year 2014-15-Instructions issued-Reg.

The Principals of all Polytechnics are informed that as per C – 09 Curriculum, the final year diploma students admitted in 2012 -13 students are attending the Industrial Training during 5th semester that started from 20th May, 2014 will be completed by 19th November, 2014.

In this context, the Principals of all the Govt., Aided, Private 2nd shift Polytechnics in Private Engg. colleges are directed to instruct their HODs /Staff of concerned Polytechnics/Branches to assess the students who are in the industrial training in 5th semester.

Further, the students of different branches in the 5th semester are now in industrial training at various Govt., Private and PSU Industries/Organisations in respective districts in the state. Hence, the Principals are directed to instruct their TPO/HOD/Senior Lecturer/Lecturer to identify the suitable training placements, where already the students of same institute/other institute for the purpose of placing the students for industrial training in the 6th semester in their final year course of study which will start from 29th November, 2014.

The Industrial training for the students admitted during the academic year 2012 -13 of the old and existing polytechnics are as per the schedule given earlier. However for the new Polytechnics commenced from the academic year 2013-14 and also for additional courses and increasing the intake from the academic year 2012 -13 the industrial training for 6 months shall be as per the Schedule given earlier.

All the Principals are requested to take necessary steps to conduct the safety orientation, insurance to the students and obtain indemnity bond before they leave for industrial training starting from 29th November, 2014.

Hence, the Principals of all the Govt., Aided, Private and 2nd shift Polytechnics in private Engg. colleges are directed to pay more attention on this issue and identify and acquire training placements that you have required for 6th semester students for industrial training starting from 29th, November, 2014.
