#### ORDER:

The Commissioner of Technical Education, Andhra Pradesh, Hyderabad in his letter 2<sup>nd</sup> read above has stated that Mr. Sarimisetty Dasarath Rayudu, has requested for transfer from Sreyas Institute of Engineering & Technology, Tattiannaram (V), G.S.I. Bandlaguda, Hyderabad to Sri Venkateshwara Institute of Science and Technology, Pulivendula Road, Tadigotla(V), C.K.Dinne(M), Kadapa Dist. at II year level in B.Tech (ECE) course for the academic year 2014-15 on medical grounds.

2. The Commissioner of Technical Education, AP, Hyderabad has also stated that the Registrar, JNTUA, Ananthapur vide letter dt.8.9.2014 has furnished the equivalency of subjects with respect to the transfer of the said student to JNTUA, Ananthapur affiliated college with the following remarks:

1. When the candidate joins in II year I sem. All the credits acquired at JNTUH shall be transferred to JNTUA.

2. When the candidate joins in JNTUA affiliated college, she shall Follow R13 regulations of the University with the following changes.

a) The degree shall be awarded based on the total no. of credits registered by the candidate prior to transfer & no. of credits to be acquired after transfer as detailed below:-

Credits registered prior transfer (up to 1 year) 56
Credits to be acquired after transfer (from II year I sem) 135
Total no. of credits to be acquired for awarding degree 191

- b) If the candidate is failed in any subject registered at JNTUH, equivalent subjects shall be suggested by JNTUA along with the credits.
- 3. The Government after careful examination of the matter, and in relaxation of condition in para 4 (4) & (7) of the G.O  $1^{\rm sl}$  read above, hereby accord permission for inter State transfer of Sarimisetty Dasarath Rayudu, from Sreyas Institute of Engineering & Technology, Tattiannaram (V), G.S.I. Bandlaguda, Hyderabad (affiliated to JNTU, Hyderabad), Telangana State to Sri Venkateshwara Institute of Science and Technology, Pulivendula Road, Tadigotla (V), C.K.Dinne (M), Kadapa Dist. (affiliated to JNTU, Anantapur), Andhra Pradesh at II year level in B.Tech. (ECE) course for the academic year 2014-15 on medical grounds subject to fulfillment of all the academic regulations of the University, now including the condition mentioned at para-2 above and minimum attendance required.
