ORDER:

In continuation of the orders issued in the reference 18th read above, the Government hereby issue orders for extension of contract and outsourcing services in various Government Departments that subsisted on 30-04-2020 with the prior permission of Finance Department for a further period of two months from 01-05-2020 to 30-06-2020, subject to adhering the relevant guidelines/ conditions as mentioned in the reference 5 and 6 read above.

2. The Heads of Departments, Secretariat and the Departmental Heads and the District Collectors are hereby authorised to extend the contractual and outsourcing services that were subsisting on 30th April, 2020, for two months i.e., from 1st May, 2020 to 30th June, 2020 at the State and the District levels respectively, provided competent authority has undertaken a review with assessment for need of continuing the engagement of the concerned staff, in view of severe fiscal constraints and have enough empirical rationale for extending the services by another two months and also by entering a fresh agreement.


