A Provisional Inter-se-Seniority List of Office Superintendents/Hostel Managers for the panel year 2020-2021 working in the Government Polytechnics/Institutions was communicated to the individuals concerned vide this office memo 3rd cited, with a request to file their objections, if any. In response to the memo, the following objections/representations have been received on the provisional seniority list from the certain Office Superintendents/Hostel Managers, concerned.

- (i) **Smt B. Ramadevi, Office Superintendent, Government Model Residential Polytechnic, Yetapaka (S.No.64)**: She has raised an objection that, the Roaster Point No. 08 (ST-W) was allocated to the muffucil quota carried forwarded in the panel year 2016-17, as there is no adequate representation. Hence, the same is being carried forwarded to the panel year 2020-21. But in the meantime of 04 years, 03 of Superintendents working in the O/o CTE were promoted to the post of AO/HS on Adhoc basis. Out of which 02 were from ST category and one of the same is women. Despite they belongs to ST category, she has requested to their candidatures shouldn't be supposed to be approved against the carry forwarded Roaster Point No.08 in the ensuing DPC, since that particular point earmarked to the muffucil quota. She has requested to consider her candidature for promotion to the post of Administrative Officer against the Roaster Point No.08 allocated for muffucil quota and earmarked for ST (W).

On verification of records, it is found that the above issue was not related to her seniority. Hence, the same is not considered. The said clarification was already issued during panel year 2019-20 also.

- (ii) **Sri K.S.K. Brahmeswara Rao, Office Superintendent, Andhra Polytechnic, Kakinada (S.No.74)**: has raised the objection that, he was promoted to the post of Office Superintendent and posted at Andhra Polytechnic, Kakinada, reported for duty on 15.09.2017. Later he was suspended from 03.11.2017 to 15.05.2018 due to private criminal case. Further, he has stated that, he was reinstated into service and the suspension period was also regularized with eligible leave. Further he has stated that, his name was shown in the seniority lists for the panel years 2018-2019, 2019-2020 and 2020-2021 without any remarks in remarks column and there are no department proceedings or remarks on him. Hence, he has requested the CTE to drop remarks against his name in the remarks column, as he is differently abled (PH-OH) employee.

On verification of records, it is found that, he was reinstated into service vide this office Procs. No.EHE02-15021/10/2018-F SEC-CTE, dt: 15.05.2018, subject to outcome of the Criminal Case No.603/17 before Hon'ble I-ACMM, Vijayawada City and his services were regularised. After thorough verification of available material, it is noticed that, the private criminal case is not yet disposed of. Hence, the same has been shown the remarks column.
