2. Representations received from Lecturers in Chemistry of Government Polytechnics.

A Provisional Seniority list of Lecturers in Chemistry (Category 10 of Class B in APTES Rules) from Zone-I to Zone-IV in Government Polytechnics, those who are in service as on 01.09.2018, prepared with reference to the Special Rules for APTES issued in G.O.Ms.No.178, Higher Education (TE.I-2) Dept., dt.09-12-2005 and in terms of the following, was communicated to the individuals concerned vide this Office Memo 1st cited, with a request to file objections, if any, on or before 20.11.2018:

i. The Hon'ble APAT issued orders dt: 30.12.2016 in the O.A No. 3639/2016 with the following observations.

"the subject matter of this O.A., and the subject matter in O.A.No.4759 of 2005 and batch, is similar and this O.A., may also be disposed of as a covered matter in terms of orders dated 27.4.2010 passed in the above said Batch of cases"

ii. The O.A. No. 4759/2005 was disposed of by the Hon'ble APAT with one of the following directions on 27.04.2010:-

"Seniority shall be fixed in terms of Rule 33 (a) read with the proviso to Rule 33 (b) of A.P. State and Subordinate Service Rules basing on the merit list prepared by the Appointing Authority on the basis of marks obtained without reference to the roster points."

iii. The opinion given by the *Additional Advocate General* vide No.24 of 2012 dated 16.06.2012 in regard to fixation of inter-se-seniority as *"the Department is required to prepare the seniority list of direct recruits, strictly based on the merit list communicated by the Public Service Commission without tampering or tinkering with the same"*.

iv. The seniority of the direct recruits is prepared based on the **Rule 33 (b) and 36 (i)** of A.P. State and Subordinate Service Rules (APSSSR) *without reference to the Roster points mentioned in the Rule 22 of APSSSR.*

The rule 36(i) states that "In respect of the candidate selected by the Andhra Pradesh Public Service Commission or other selecting authorities by direct recruitment, shall be with reference to their ranking assigned irrespective of the date of commencement of their probation in that category

v. The seniority of the candidates, who **REPATRIATED** under G.O.Ms. No. 610, General Administration (SPF - A) Department, dt: 30.12.1985 or under AP State Bifurcation Act, is protected under the provision in Para 5(2) (c) of the Presidential Order relating to the inter-local cadre transfers candidates and as per the **Rule 35 (a)** of AP State and Subordinate Service Rules, 1996 which States that

"The seniority of a member of a service, class or category transferred from one unit of appointment to another unit of appointment, on administrative grounds, shall be, determined with reference to the date of seniority of such member in the former unit."

vi. The seniority of the candidates, who are **TRANSFERRED ON REQUEST**, is fixed in accordance with the Rule 35 (b) of AP State and Subordinate Service Rules, 1996 and the Seniority of the candidates, who are **RE-ALLOTTED** by APPSC is fixed as per the Rule 37 of AP State and Subordinate Service Rules, 1996

vii. The date of seniority of the candidates is assigned as per The **Rule 16 (a)** of the AP State and Subordinate Service Rules, 1996 which States that

"A person appointed in accordance with the rules, otherwise than under rule 10, by direct recruitment shall commence his probation from the date of his joining the duty or from such other date as may be specified by the appointing authority"

As per this rule, the Appointing Authority i.e. the Commissioner of Technical Education is assigning the same date to All the Direct Recruits Such as Date of Appointment Order or any other date that shall not adversely affect any person who has been appointed earlier or simultaneously, to the same service, class or category in the same unit.

viii. The date of seniority is assigned as 11.02.1993 based on the order passed on 12.10.2008 by the Hon'ble High Court in WP no. 19459/2003 for the Non-APPSC candidates who were appointed prior to

11.02.1993 and regularised in pursuance of G.O.Ms.No.193, General Administration (Services-A) Department dated 14.03.1990.

- ix. The seniority of the Lecturers, who have been appointed by the method of 'appointment by promotion', may vary subject to the fulfilment of the conditions as per the rules in vogue.

In response to this Office Memo, the following objections/representations have been received on the provisional seniority list from the incumbents for corrections/inclusions/omissions in the seniority list. After careful examination, the objections received from the incumbents are disposed off as shown below against their names.

1. Sri Y.Srinivasa Rao, Lecturer in Chemistry, Govt. Polytechnic, SSSD Chinamerangi (Sl.No.2 in Zone-I):

He represented that he joined in the Department as Associate Lecturer in Chemistry on 05.08.1995, one more candidate Sri Srinivasa Yogi was also selected for the Associate Lecturer post in the same appointment order, but relinquished to join in the Department. Sri P.Srinivasa Reddy, was appointed in the post which was relinquished by Srinivasa Yogi, as a waiting candidate in separate order on 25.03.1996. By the time of entry of Sri P.Srinivasa Reddy into the Department, the incumbent completed 7 months of service. He further stated that from 1995 to 2010, he was placed over Sri P.Srinivasa Reddy, but in the year 2010, the incumbent is placed next to Sri P.Srinivasa Reddy. He approached the Hon'ble APAT and the Hon'ble APAT in OA No.2874/2012 dated 16.07.2015 issued orders in his favour stating that the applicant (Sri Y.Srinivasa Rao) is entitled to be shown as senior to the unofficial respondent (Sri P.Srinivasa Reddy) as per merit in 1995 selections to the post of Lecturer in Chemistry.

On verification of records and in view of the orders of the Hon'ble APAT in OA No.2874/2012, dated 16.07.2015, the plea of Sri Y.Srinivasa Rao is considered favourably and he is placed above Sri P. Srinivasa Reddy, Lecturer in Chemistry, Govt. Polytechnic, Amadavalasa.

It is informed that the seniority of the Lecturers, who have been 'appointed by promotion', may vary subject to the fulfilment of the conditions as per the rules in vogue.

While disposing of the above objections, the provisional seniority list of Lecturer in Chemistry in Govt. Polytechnics from Zone-I to Zone-IV as on 01.09.2018 is finalised and the Final Seniority list is communicated herewith to the individuals concerned. The representations of the other incumbents with regard to name corrections, incorporation of higher qualification degrees, regularisations, place of working etc., are examined and incorporated as per eligibility and the available records. The Seniority is, however, subject to the outcome of the SLPs/W.Ps/C.As/ O.As/MAs, if any, pending before the Hon'ble Supreme Court of India, Hon'ble High Court of AP., and Hon'ble APAT.

The Principals concerned are requested to communicate the final seniority list of the Lecturers in Chemistry to the individuals concerned duly obtaining acknowledgements from them.
