A Provisional Inter Se Seniority list of Senior Lecturers in Electrical and Electronics Engineering (Category 3 of Class B in APTES Rules) in Government Polytechnics those who are in service as on 01-09-2016, prepared with reference to the Special Rules for APTES issued in GO. Ms. No. 178, Higher Education (TE.I-2) Dept., dt. 09-12-2005, was communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 17-06-2017. In response to this office Memo, the following objections/representations have been received on the provisional Inter Se seniority list from the incumbents for corrections/inclusions/omissions in the seniority list. After careful examination the objections received from the incumbents are disposed off as shown against their names.

1. Dr P.Nagendra, Government Polytechnic, Urvakonda (05):-The incumbent in his representation has requested to place his name before K.D.V Narasimha Rao and below the name of Sri B.Samba Siva Reddy and requested to correct his date of join as Senior Lecturer as 03/10/2011 instead of 03/10/2011/07/10/2011

On verification of the records it is found that, as per the merit list communicated by APPSC Dr P.Nagendra, Government Polytechnic, Urvakonda is senior than Sri K.D.V. Narasimha Rao and the joining date of Sri K.D.V. Narasimha Rao 27/11/1996 is limited to the date of his Senior i.e Dr P.Nagendra date of joining 29/11/1996. Further Sri K.D.V. Narasimha Rao repatriated to Zone-II from Zone-IV under G.O 610. As per the Rule 33(d) of APSSR 1996 once the joining date of junior was limited to his senior cannot be altered even though he repatriated to another Zone as per G.O 610. Hence the plea of Dr.P.Nagendra is considered and his name is placed over and above Sri K. D.V. Narasimha Rao.

Further, the request of Dr P.Nagendra, Government Polytechnic, Urvakonda for correction of his promotion date as 03/10/2011 instead of 03-10-2011/07-10-2011as senior Lecturer is not feasible to consider. Because his promotion date was limited to his senior date of promotion. Hence, his plea is herewith rejected.

2. Smt. N.Vasanthi, MRAGR Government Polytechnic, Vizianagaram(S.No.22):-The Principal has forwarded the objection raised by the above incumbent stating that, her name is showed after the 1995&96 batch though she was selected in 1987 and her services were regularized in the cadre of Lecturer on 20/07/1990. Hence she requested for consider objection and place her name in the appropriate place and also make entry of her account test passing details in the seniority list.

On verification of the records, her plea is considered and her name is shown in the appropriate place and her account test passing details also incorporated in the seniority list.

2. **B.Sai Lakshmi Prasanna, Government Polytechnic, Tadipatri(S.No.25):-** The incumbent in her representation has stated that, she was appointed as Associate Lecturer(re designed as Lecturer) on 01/07/1997 and her junior Sri M.P. Rajesh was appointed on 22/04/1998 and she was denied her promotion as Senior Lecturer in the panel year 2010-11 and her junior was promoted in the said panel year. Later she got her promotion as Senior Lecturer in the panel year 2011-12 and reported for duty on 16/07/2012. Subsequently she undergone on leave due to her personal problems from 01/08/2012 to 10/01/2013 and 22/02/2013 to 17/10/2013 again she was on leave from 14/02/20014 to 03/06/2015 and joined for duty on 01/06/2016. In view of the above she requested protect her seniority on par with his junior and place her in the appropriate place in the seniority list.

On verification of the records it is found that, B.Sai Lakshmi Prasanna, Government Polytechnic, Tadipatri was joined in the department as Associate Lecturer(re designed as Lecturer) on 01/07/1997 and her junior Sri M.P. Rajesh was appointed on 22/04/1998 and she was denied her promotion as Senior Lecturer in the panel year 2010-11 and her junior was promoted in the said panel year. Hence her seniority is protected as per the Rule 33 & 36 of APSSR 1996 and her name is showed on and above Sri M.P Rajesh.

4. Smt. M. VASUNDHARA, SENIOR LECTURER IN EEE, GPT, KANDUKUR (S.No.32): The incumbent has stated that, her date of promotion shown in the provisional Inter Se seniority list as 19-07-2013. As her name was considered for promotion to the post of Senior Lecturer in EEE in the DPC for the panel year 2010-11, but deferred her promotion due to pendency of alleged charges. Later, the Government has dropped the charges on her as per the G.O. Rt. No. 489, (VC-II) Dept., dt: 02-07-2013 and promoted to the post of Senior lecturer w.e.f 19.07.2013 Hence, she has requested to consider her seniority in the cadre of Senior Lecturer from 03-10-2011.

On verification of the records it is found that Smt. M. Vasundhara, Sr. Lecturer in EEE was one of the responsible people in theft accord in CAD lab Govt. Polytechnic, Gudur and the article of the charges were framed against her. Later the Govt. take a lenient against her and given recorded warning vide G.O.Rt.No.489 Higher Education (VC.II) Department, dated: 02.07.2013. Hence, her candidature for promotion to the post of Senior Lecturers was deferred and was promoted w.e.f 19.07.2013. In view of the above facts her request for prepone of her promotion from 19.07.2013 to 03.10.2011 is not feasible to consider. Hence, her plea is herewith rejected.

- 2. The Provisional Inter Se Seniority List of Senior Lecturers in Electrical and Electronics Engineering of Government Polytechnics those who are in service as on 01-09-2016 is finalised with the above corrections/omissions/inclusions and the final Inter Se seniority list is communicated herewith to the individuals concerned. The Seniority is however, subject to the outcome of the SLPs/W.Ps/C.As/ O.As/ MAs if any pending before the Hon'ble Supreme Court of India, High Court of AP., and Hon'ble APAT.
- 3. The Principals concerned are requested to communicate the Final Inter Se seniority list of Senior Lecturers in Electrical and Electronics Engineering to the individuals concerned duly obtaining acknowledgments from them.
