It is brought to the notice of the Special Commissioner of Technical Education, A.P., Vijayawada that internal examinations of certain Colleges are going to be held which will be coinciding with the Schedule of General Elections-2019. Further, it is also informed that certain College buildings have been notified as counting centers for the election related work.

Keeping in view of the above facts, the Principals of all Government / Aided/ Private Un-aided Polytechnics / Second -Shift Polytechnics in the existing Engineering Colleges and D-Pharmacy institutions working under the control of this Department are requested to take necessary action in re-scheduling the exams if any and to de-notify the buildings which are earmarked as counting centers by the O/o Chief Electoral Officer, Velagapudi, Amaravathi, so as to enable the District Election Officers to complete the Election process of General Elections-2019, without any hurdle.

Further, Regional Joint Directors of Technical Education, Kakinada & Tirupathi are hereby requested to monitor & ensure that proper measures be taken so as to complete the Election process of General Elections-2019, without any hurdle and further Instructions may be issued to all the colleges under their jurisdiction to carry out, the other day to day academic & administrative activities in those buildings which are not notified in order not to hamper the Election process of General Elections-2019.
