ORDER:

In the reference first read above, orders were issued approving the names of Heads of Sections for promotion to the posts of Principals in Government Polytechnics in the State of A.P. for the panel year 2017-2018.

2. In the reference second read above, the Special Commissioner of Technical Education, A.P., has furnished the proposals for posting of certain Heads of Sections on Promotion as Principals and requested the Government for issue of orders.

3. Government after careful examination, hereby promote the following Heads of Sections of Government Polytechnics as Principals in the Scale of Pay of Rs.37400 -67000 with an AGP of Rs.10,000/- with all usual allowances applicable from the date of taking charge, purely on temporary basis, under rule 10 (a) of the Andhra Pradesh State and Subordinate Services Rules.

4. All the promotions ordered below shall be subject to the outcome of various R.Ps/O.As/W.Ps/C.As/CCs. etc. if any, pending in Hon'ble Andhra Pradesh Administrative Tribunal and Hon'ble Andhra Pradesh High Court.

5. The Heads of Sections promoted as Principals and shown below should join their respective posts at the respective stations within a period of 15 days from the date of receipt of orders as required under Sub Rule (b) of Rule 11 of the Andhra Pradesh State and Subordinate Service Rules, 1996 and if they fail to join the promotional post within the stipulated time or evade to join the post by proceeding on leave, they shall lose their promotion right/ offer for the current panel year and the name of the candidate shall be placed before the next Departmental Promotion Committee for consideration in the next year panel subject to availability of vacancy.
