ORDER:

In the reference read above, and as per Rule 3 of the Special Rules for APTES issued in the G.O.Ms.No.178, Higher Education (TE.I-2) Department, Dated: 09.12.2005, the Commissioner of Technical Education, A.P., Hyderabad, has furnished a Provisional Inter-Se-Seniority List of Principals in Government Polytechnics who have completed 03 years of service in the feeder category as on 01-09-2016 based on their service reckoned from the date of regular appointment to the cadre of Principal which was communicated to the individuals concerned by Commissioner of Technical Education vide Memo No.C3/1673/2016, Dt.12.01.2017 with a request to file objections, if any, on or before 27-01-2017. The Commissioner of Technical Education has examined the objections received from the incumbents and forwarded the same together with her recommendations to Government for issue of final seniority list of Principals in Government Polytechnics as on 01-09-2016.

- The Government, after careful examination of the objections raised by certain individuals on the provisional seniority list, duly taking into consideration the remarks offered by the Commissioner of Technical Education on each of the objections, have come to the conclusion as indicated below:-
- (1) Sri G. Sudhakar Reddy, Principal, S.V. Govt. Polytechnic, Tirupathi (Sl.No12): He requested to place his name in the Sl.No.01 among others on vertical seniority, based on his date of promotion as Senior Lecturer and as well as his date of birth.

On verification of records it is found that the request of the above incumbent is not feasible to consider as he belongs general section and promoted in the same. There is a ratio (2:5) in between Non-Engineering and Engineering branches for promotion to the post of Principal. He promoted in the above said ratio. Hence, his request is rejected.

(2) Smt. N. Aroji Rani, Principal, Govt. Polytechnic, Gannavaram (Sl.No.24), Sri K.S.Vara Prasad, APT, Kakinada (Sl.No.40), Sri Phaneendra Prasad, Principal, Govt. Polytechnic, Visakhapatnam (Sl. No. 41): The above 03 Principals requested to fix their seniority as per the G.O.Ms.No.52 Higher Education (TE) Department Dt:27/08/2016, and stated that, in the Special Rules for A.P. Technical Education services, issued vide G.O.Ms.No.178 Higher Education (TE.2) Department, Dt.09.12.2005 no rules were prescribed for preparation of Seniority list of Principals for promotion to the post of Joint Director. Hence, in the absence of the special rules for governing seniority for any particular post, the seniority in the feeder category has to be taken. The 03 above Principals requested to protect their seniority and place them in the appropriate place.

objection, it is observed W.r.to the

vide Memo Government that No.11703/TE.I/A2/2006-3, Dated: 12.12.2006 of Higher Education (TE.I) Department have accorded permission for condoning the shortfall of service to the extent of 16/17 days as on 1.9.2006, in respect of Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D. Phanindra Prasad, and accordingly they have been considered for promotion to the post of Principal on ad-hoc basis through DPC as per their seniority and their names have

been recommended by the DPC for empanelment for promotion to the posts of Principals for the panel year 2006-07 against the SC carry forward vacancies, in their meeting held on 30.08.2007. Based on the recommendations of the DPC, their names have been approved for promotion to the posts of Principals for the panel year 2006-07 vide G.O.Ms.No.159, H.E.(TE.1) Dept., Dated 31.8.2007 and they were promoted to the posts of Principals vide G.O.Ms.No.185, H.E. (TE.I) Dept., dated 30.9.2007 and they assumed charge of the post of Principal on 01-10-2007. As per the clarification issued in Memo No.53975/Ser.D/ 2003-3, G.A. (Ser.D) Department, Dated:9.1.2001, they are entitled to commence their probation in the category of Principal from the date following the date of completion of the required period of 3 years in the lower category of Head of Section. As they completed the required period of (3) years of service in the category of Head of Section by 16.9.2006 / 17.9.2006, the above first (3) incumbents are eligible to commence their probation in the category of Principal to the date of their promotion i.e. 1-10-2007.

On verification of records it is found that, the above 03 incumbents names was not included in the seniority for the panel year 2006-07 as they have not completed the requisite period of 03 years for promotion to the post of Principal in the feeder category i.e Heads of Section.

Hence, the Higher Education (TE.I) Department have accorded permission to the above 03 incumbents only for condoning the shortfall of service to the extent of 16/17 days as on 1.9.2006, against the SC carry forward vacancies. As per the guidelines of the Department of Personnel & Training, GoI, (O.M. No.20011/1/2008-Estt.(D) Dated 11th November 2010) Clarification on reservation roster vis-a-vis seniority has been given as follows:-

"In case of promotion, vacancies meant and reserved for SC/ST are determined through the roster points in the reservation roster. It is clarified that the said reservation roster / points are meant only for identifying the vacancy that goes to a particular category of officer and in no way acts as a determinant for fixation of seniority of the officer in a panel recommended by the DPC."

The above 03 incumbents are juniors to the promotees of the panel year 2006-07. In view of the above facts Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D. Phaneendra Prasad were also promoted in the panel year as per the recommendation of the Departmental Promotion committee. Hence, the 03 incumbents names are placed below to the 2006-07 panel approved seniority list candidates and it is incorporated in the proposed final seniority list for promotion to the post of Joint Director / Regional Joint Director.

(3). Sri A.Nirmal Kumar Priya (Sl. No. 42), Joint Secretary/COE, SBTET, A.P.: The incumbent has requested to make correction of his date of birth and to place him at Sl.No 07 after K.S.Vara Prasad instead of Sl.No.42. He has further stated that his name was placed at Sl. No. 91 as his regular appointment as senior lecturer is 31.10.1998 and Sri S.V. Kumar, HMES listed at Sl. No. 102, the dated of regular appointment as Senior Lecturer is 13.11.1998. Sri S.V. Kumar is senior to Sri D. Phaneendra Prasad who is presently working as Principal, Govt. Polytechnic, Visakhapatnam. Accordingly, he has senior to Sri D. Phaneendra Prasad as per date of regular appointment as Senior Lecturer that is 13.11.1998.

With reference to the objection raised by the above incumbent, it is observed that Government vide Memo No.11703/TE.I/A2/2006-3, Dated: 12.12.2006 of Higher Education (TE.I) Department have accorded permission for condoning the shortfall of service to the extent of 16/17 days as on 1.9.2006, in respect of Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D. Phaneendra Prasad and accordingly they have been considered for promotion to the posts of Principals on ad-hoc basis through DPC as per their seniority and their names have been recommended by the DPC for empanelment for promotion to the posts of Principals for the panel year 2006-07 against the SC carry forward vacancies in their meeting held on 30-8-2007. Based on the recommendations of the DPC, their names have been accordingly approved for promotion to the posts of Principal for the panel year 2006-07 vide G.O.Ms.No.159, H.E.(TE.1) Dept., Dated

31.8.2007 and they have been promoted to the posts of Principal vide G.O.Ms.No.185, H.E. (TE.I) Dept., dated 30.9.2007 and they assumed charge of the Post of Principal on 1-10-2007. As per the clarification issued in Memo No.53975/Ser.D/ 2003-3, G.A. (Ser.D) Department, Dated:9-1-2001, they are entitled to commence their probation in the category of Principal from the date following the date of completion of the required period of 3 years in the lower category of Head of Section. As they completed the required period of (3) years of service in the category of Head of Section by 16.9.2006 / 17.9.2006, the above first (3) incumbents are eligible to commence their probation in the category of Principal to the date of their promotion i.e. 1-10-2007.

Hence, the names of the above 03 Principals are shown at the appropriate place, i.e. Sl. Nos (12), (13) and (14) respectively. The plea of Sri A.Nirmal Kumar Priya (S. No. 42), Joint Secretary / COE, SBTET, A.P to place his name above Sri D. Phaneendra Prasad cannot be considered as they were promoted in the panel year 2006-07. Sri A.Nirmal Kumar Priya's name was approved in the panel year 2007-08 and was promoted in the same panel year vide G.O.Ms.No.243, Dt:18.10.2008 of the Higher Education(TE.I) Department. Hence, his name is placed along with the 2007-08 prometees in the Sl.No (15). The same is incorporated in the proposed final seniority list for the panel year 2016-17 for Promotion to the post of Joint Director/Regional Joint Director.

(4). Sri N.S. Venkatesh Kumar, Principal, Govt. Polytechnic, Pillaripattu (SI.No.32):- The incumbent requested revise his seniority and include his name in the seniority list for promotion to the post Principals for the panel year 2009-10 instead of 2010-11 as he completed his M.Tech trough CCC has got equal validity on par with regular courses.

On verification of records it is found that, Sri N.S. Venkatesh Kumar, Principal completed his M.Tech. (Industrial Engineering and Management through Correspondence cum contract (CCC) Programme from JNTU in the year 1991. His name was placed in the provisional seniority list of Principals for the panel year 2009-10 but, he didn't got promotion to the post of Principal in that panel year due to the validity of the M.Tech. CCC programme. Further he approached Hon'ble APAT in O.A.No 5744/2010 praying tribunal to consider his M.Tech. CCC certificate as valid for promotion to the post of Principal. The Hon'ble APAT passed an interim order on 27/08/2010 as follows:-

"Pending further orders, there shall be a direction to the respondents to consider the claim of the applicant for promotion to the post of Principal, Polytechnic in the ensuing DPC, which is slated on 31/08/2010 or any subsequent date for the panel year 2009-10".

In view of the above directions of the Hon'ble APAT vide Lr.No 12374/TE.1/A2/10-1, Dt:16/10/2010, the Principal Secretary to Government requested the All India Council for Technical Education, New Delhi for clarification on the validity of the M.Tech CCC programme. The AICTE in its Lr.No F1-4/PC/2010/993, Dt:07/12/2010 of the Advisor-I, AICTE, New Delhi has informed that "further first notification No F-304-4/CCF/REG/94 after establishment of AICTE as statutory body for grant of approval of the Council for establishment of new Technical institutions including University departments & Deemed University was issued on 31/10/1994, hence, the question whether M.Tech. Degree qualification acquired through Correspondence Cum Contract (CCC) programme conducted by JNTU in the year 1991 is recognized or not by AICTE as statutory body does not arise. Further the Principal Secretary to Government addressed a letter vide Lr.No 12374/TE.1/A2/10-2, Dt: 04/05/2011 to the Secretary to A.P., State Council of Higher Education, Hyderabad for clarification, whether the M.Tech. Degree acquired through Correspondence-Cum-Contract (CCC) Programme conduct by JNTU, Hyderabad in the year 1991 was recognized as Post Graduate Degree in Engineering, keeping in view of the clarification given by AICTE, New Delhi. The Secretary, APSCHE/PGP/Equip./M.Tech-Hyderabad in his Lr.No. APSCHE, CCC/2011, Dt:26/05/2011 has informed that JNTU, Hyderabad has certified that M.Tech. (CCC) offered in various disciplines by the University (one batch only), is equivalent to all the regular M.Tech courses which are being offered by JNTU,

Hyderabad. Hence, his case will be considered only if review DPC is conducted for the panel year 2009-10.

(5). Sri A. William Carey, Principal, MRAGR Govt. Polytechnic, Vizianagaram (SI.No.43):- The incumbent requested to correct his date of birth as 01/06/1964 instead of 06/01/1964 and also requested to correct his name as A.WILLIAM CARRY instead of A.WILLIAM CARRY which was mentioned wrongly in the revised provisional seniority list of Principals for the panel year 2016-17.Sri A.William Carey, Principal, MRA GR GP, Vizianagaram further stated that, he was promoted to the post of Principal vide G.O. Ms. No 194, Higher Education (TE-II) Department, Dt:27/09/2010 as per Roaster Point RP-22 SC (W). In the final Seniority list of Principals as on 01/09/2015, as per the G.O.Ms.No.52, Higher Education (TE-II) Department, Dt: 27/08/2016 he was shown at SI.No.19 and now in the revised provisional seniority list his name shown in the SI.No.43. Hence he requested to protect his seniority and place in the appropriate place in the seniority list for the panel year 2016-17.

On verification of the records his date of birth was corrected as 01/06/1964 instead of 06/01/1964 and his name also corrected as A.WILLIAM CARRY instead of A.WILLIAM CAREY. It is to submit that, Sri Willam Carry was promoted to the post of Principal in the panel year 2009-10 vide G.O. Ms. No 194, Higher Education (TE-II) Department, Dt:27/09/2010 in the Roaster Point RP-22 SC (W) and he was joined on 19/11/2010 and his date of regularization was limited to 19/12/2010 to his seniors. In view of the above facts, the name of Sri A.William Carry, Principal, MRA GR GP, Vizianagaram kept in the appropriate in the seniority list along with seniors who were also promoted in the said panel year i.e 2009-10. The same is incorporated in the proposed final seniority list for the panel year 2016-17 for promotion to the post of Joint Director/Regional Joint Director.

- 3. In view of the facts mentioned above, the Government, after careful examination of the provisional seniority list of Principals in Government Polytechnics, while disposing of the objections raised by certain Principals as mentioned above, hereby finalize and communicate the final seniority list of Principals in Government Polytechnics, for the panel year as on 01.09.2016, as appended to this order as Annexure. The Commissioner of Technical Education is directed to communicate the same to all the Principals concerned mentioned in the Annexure.
- 4. The Commissioner of Technical Education, Hyderabad shall take necessary action as instructed above.
