ORDER:

In the G.O. 1st read above, Government have issued orders for implementation of AP Revised AICTE Scales of Pay 2006 to the Teachers, Library and Physical Education personnel working in Government Polytechnics / Institutions w.e.f., 01.01.2006 and it was stated in para 2(xiv) in Appendix-A as follow:

“Head of the Department (HOD), completing 3 years of service in the AGP of Rs.9,000 and possessing a Ph.D. degree in the relevant discipline shall be eligible, subject to other conditions of academic performance as laid down by the AICTE, shall be placed in Rs.37,400-67,000 with AGP of Rs.10,000.”

2. In circumstances reported by the then Commissioner of Technical Education in the reference 7th read above and clarifications given by the AICTE, New Delhi in the reference 2nd read above, Government after careful examination of the matter, hereby amend the para 2(xiv) in Appendix-A of the G.O.Ms.No.209, Higher Education (TE.I) Department, dt.20.11.2010 as follows:

“Head of the Department (HOD) / Lecturer (Selection Grade), completing 3 years of service in the AGP of Rs.9,000 and possessing a Ph.D. Degree in the relevant discipline shall be eligible, subject to other conditions of academic performance as laid down by the AICTE, shall be placed in Rs.37,400-67,000 with AGP of Rs.10,000.”

3. The Director of Technical Education, Andhra Pradesh, Mangalagiri shall take further necessary action, accordingly.
