It is informed that as per Curriculum C-16, Industrial Training for a period of 06 months for students of all Branches of Diploma in their final year has to commence as per the following schedule. However, the Principals are instructed to send students of VI Semester also for Industrial Training if possible for the maximum number because of COVID -19 uncertainty for conducting regular classes at the Institution.

It is informed that as per Curriculum C-16, Industrial Training for a period of 06 months for students of all Branches of Diploma in their final year has to commence as per the following schedule.

Semester ( 2020-21 A Y)	Commencement of Industrial Training
5 <sup>th</sup> Semester	10/07/2020 to 09/01/2021
6 <sup>th</sup> Semester	10/01/2021 to 09/07/2021

However, due to the unprecedented difficult times caused by the outbreak of COVID-19 pandemic, AICTE, New Delhi in its letter (reference 2) has issued guidelines based on the recommendations of the UGC Constituted Committee on examinations and academic calendar and in the D.O. Letter from the Secretary, UGC, New Delhi Date 04-05-2020 (reference 4) gives a frame work for internship under the current situation.

In this regard, all the Principals (Govt / Aided / Private II Shift Polytechnics in Engineering Colleges) are therefore instructed to plan for Industrial Training. The Principals are instructed to take necessary measure to allot the industrial training blended with appropriate study project (to be attended from home) and scattered internship when the situation comes to normal, in view of the spread of COVID- 19 pandemic.
