This office has instructed the Stakeholders of 19 modules, vide reference cited to verify the correctness of the modules assigned to them and offer their remarks and to submit the compliance report within one week from the date of receipt of the orders to enable the department to increase the usage of MIS application at the Commissionerate / SBTET AP and in the Polytechnics with the help of IT-Cell in the Commissionerate.

Accordingly all the Stakeholders verified their respective modules and submitted their remarks which are shown in Annexure attached in the (draft 3) Out of 19 modules, stakeholders of 16 modules have given the sign-of confirmation. Two (02) Modules were kept on hold (Pre Examination and Post Examination). One (01) Module i.e Examination Time Table Management (Final External Exam Time Tables generation) is not yet confirmed by the Stakeholder but several reviews have been done by stakeholder. Further it is informed that, once the sign-of process is completed by the stakeholders, the MIS application will again be forwarded for Security Audit to the APTS. The vendor has prepared User Manuals and Handouts for each module which can be used by stakeholders at the O/o the DTE/SBTET AP and the end users at the polytechnic level.
