With reference to the admissions under Foreign Nationals/Persons of Indian Origin/Children of Indian Workers in Gulf (FN/PIO/CWG) quota, the institutes have to submit the list of admitted students to Commissioner of Technical Education for antecedents verifications vide reference 1st cited.

But in practice, the institutes have been submitting the list of student data admitted under PIO/FN/CWG quota along with relevant documents to Commissioner of Technical Education throughout the year. To curtail this, a web application is developed to submit the admitted student data under PIO/FN/CWG quota by the institutes through online web portal www.dteapengg.in from the academic year 2020-21 onwards.

Further, it is informed that, vide reference 1st cited, the committee shall be constituted under the chairmanship of the Commissioner of Technical Education, A.P to look into the list of admitted candidates along with the relevant documents of antecedents verification as well as academic qualifications. The committee will forward the eligible candidates list to competent authority for further necessary action.

Hence all the institutes who are having AICTE approval for FN/PIO/CWG admissions for the academic year 2020-21 shall submit the data through online only as per the following details:
