ORDER:-

In the reference read above, and as per Rule 3 of the Special Rules for APTES issued in the G.O.Ms.No.178, Higher Education (TE.I-2) Department, Dated: 09-12-2005, the Commissioner of Technical Education, A.P., Hyderabad, has furnished a Provisional Inter-Seniority List of Principals in Government Polytechnics who have completed 03 years of service in the feeder category as on 01-09-2015 based on their service reckoned from the date of regular appointment to the cadre of Principal which was communicated to the individuals concerned by Commissioner of Technical Education vide Memo Dated: 14-03-2016. The Commissioner of Technical Education has examined the objections received from the incumbents and forwarded the same together with her recommendations to Government for issue of final seniority list of Principals in Government Polytechnics as on 01-09-2015.

2. The Government, after careful examination of the objections raised by certain individuals on the provisional seniority list, duly taking into consideration the remarks offered by the Commissioner of Technical Education on each of the objections, have come to the conclusion as indicated below:-

1) SRI V.PADMA RAO, PRINCIPAL, GPW, ETHAMUKKALA(SI.No.8): The incumbent has stated that his date of birth is noted as 7.5.1965 in the provisional seniority list and therefore requested to change his date of birth as 5-7-1965 instead of 7.5.1965.

On verification of certificates, the date of birth of the incumbent has been corrected accordingly in the seniority list.

2) SRI M.FAMA SUBBA REDDY, PRINCIPAL, ESCGP, NANDYAL (SI.No.09), SRI V.S.DUTT (S. No.11), DD (Academic), O/o CTE, A.P. and SRI S.V.SATYANARAYANA (SI. No.12), PRINCIPAL GPW, KAKINADA: The incumbents have represented that the Principals, viz., Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D.Phanindra Prasad shown at Sl. Nos.(5) to (7) respectively in the provisional seniority list are not included in the final seniority list of Heads of Sections (Engineering) as on 1.9.2006 communicated in G.O.Ms.No.198, H.E. (TE.1) Dept., dated:21.12.2006 and were promoted along with them as Principals on ad-hoc basis. They have also stated that since they did not complete 3 years of service in the category of Head of Section as on 01-09-2006 and there were no sufficient SC qualified candidates, they have been considered and promoted as Principals and reported for duty on 01.10.2007 and therefore, requested to place their names above Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D.Phanindra Prasad.

The incumbent Sr M. Ramasubba Reddy also represented that Sri B.K. Surya Prakash (S.No.04) in the seniority list has been promoted as Principal after 2007 as per provision 1 in 25 for the candidates who were recruited directly to the post of Head of section. He also stated that Sri B. Surya Prakash (S.No.04) has been notionally promoted from 15.03.2004 and requested to show Sri B.K. Surya Prakash (S.No.04) below him in the seniority list.

With reference to the objection raised by the incumbents it is observed that Government vide Memo No.11703/TE.I/A2/2006-3, Dated 12.12.2006 of Higher Education (TE.I) Department, have accorded permission for condoning the short fall of service to the extent of 16/17 days as on 1.9.2006, in respect of Smt. N. Aroji Rani, Sri K.S. Vara Prasad and Sri D. Phanindra Prasad and accordingly they have been considered for promotion to the posts of Principals on ad-hoc basis through DPC as per their seniority and their names have been recommended by the DPC for empanelment for promotion to the posts of Principals for the panel year 2006-07 against the SC carry forward vacancies in the meeting held on 30-8-2007. Based on the recommendations of the DPC, their names have been accordingly approved for promotion to the posts of Principals for the panel year 2006-07 vide G.O.Ms.No.159, H.E.(TE.1) Dept., Dated 31.8.2007 and they have been promoted to the posts of Principals vide G.O.Ms.No.185, H.E. (TE.I) Dept., dated 30.9.2007 and they assumed charge of the Post of Principal on 01-10-2007. As per the clarification issued in Memo No.53975/Ser.D/2003-3, G.A. (Ser.D) Department, Date:9.1.2001, they are entitled to commence their probation in the category of Principal from the date following the date of completion of the required period of 3 years in the lower category of Head of Section. As they have completed the required period of (3) years of service in the category of Head of Section by 16.9.2006 / 17.9.2006, the above first (3) incumbents were eligible to commence their probation in the category of Principal to the date of their promotion i.e. 01-10-2007.

Hence, the names of the above (3) Principals are shown at the appropriate place, i.e., at Sl. Nos. (5), (6) and (7) respectively. The plea of the incumbents to place their name above the said (3) Principals cannot be considered and therefore their objection is rejected.

Sri B. K. Surya Prakash (S.No. 04) was recruited directly as Head of Section and considered for promotion against vacancies reserved for directly recruited Head of Sections. Hence, Sri M. Ramasubba Reddy cannot claim seniority over Sri B. K. Surya Prakash (S.No. 04) and his request to place him above Sri B. K. Surya Prakash (S.No. 04) cannot be considered, and hence his objection is rejected.

3. SRI A. WILLIAM CAREY (S. No. 19), PRINCIPAL, MRAGR G.P. VIZIANAGARAM: He has requested to fix his seniority in the category of Principals with retrospective effect w.e.f. 01.10.2007 and place him over and above Smt. N. Aroja Rani (Sl.No. 05). Government vide Memo No.11703/TE.IA2/2006-3, Dated 12.12.2006 of Higher Education (TE.I) Department have accorded permission for condoning the shortfall of service to the extent of 16/17 days as on 1.9.2006, in respect of Smt N. Aroji Rani, Sri K.S. Vara Prasad and Sri D. Phanindra Prasad only and accordingly they have been considered for promotion to the posts of Principals on ad-hoc basis through DPC as per their seniority and their names have been recommended by the DPC for empanelment for promotion to the posts of Principals for the panel year 2006-07 against the SC carry forward vacancies in the meeting held on 30-8-2007. Since the incumbent was not considered for promotion in the panel year 2006-07 along with above said (3) Principals, his claim to place him above the said (3) Principals cannot be considered and therefore his objection is rejected.

4. SRI P. KOTI NAGESWAR RAO (S.No. 27), PRINCIPAL, G.P., REPALLE: He has requested to correct his name as P. KOTI NAGESWAR RAO instead of T. KOTI NAGESWAR RAO.

On verification of records, the same has been corrected accordingly in the Seniority list.

5. SRI V VIJAYA KUMAR (S.No. 37), GP, GUDUR, Sri N.S.VENKATESH KUMAR, PRINCIPAL, GP, PILLARIPATTU (Sl.No.36): They have requested to review their promotions as Principal for the panel year 2009-10 instead of 2010-2011.

Since, conduct review DPC is prerogative of the Government and the same is not conducted so far, the seniority remains unaltered. Hence, their objection is rejected.

3. In view of the facts mentioned above, the Government, after careful examination of the provisional seniority list of Principals in Government Polytechnics, while disposing of the objections raised by certain Principals as mentioned above, hereby finalize and communicate the final seniority list of Principals in Government Polytechnics, as appended to this order as Annexure. The Commissioner of Technical Education is directed to communicate the same to all the Principals concerned mentioned in the Annexure.

4. The Commissioner of Technical Education, Hyderabad shall take necessary action as instructed above.


