There is a tremendous growth in the Industrial sector in India. Studies say that India will have youth in the age group of 18 – 25 years @ 54 % of the population by 2029. We also perceive high levels of unemployment. It is against this backdrop that mission mode projects like **‘Pradhan Mantri Kaushal Vikas Yojana’** by Technical Institutions (PMKVY-TI) in Academic Year 2017-18 are initiated to bridge the gap between Industries needs and output from the Educational Institutions.

PMKVY-TI is implemented through AICTE approved Technical Institutes and Polytechnics which are willing to run Skill Development Program using existing infrastructure. In this regard, it is submitted that AICTE has opened registrations from 07.06.2017 for AICTE approved Institutions for running technical skill based courses for the academic year 2017-18 and selected Institutions may run certificate courses “NSQF”. The Notification that has been enclosed gives a detailed note on who are eligible to opt for the Courses and the funding pattern. An application has to be submitted by the AICTE approved Institutions. Visit <http://www.aicte-india.org> for further details.

In view of the resources (Infrastructure and staff) available in the Government Polytechnics of Andhra Pradesh the possibility of conducting courses suggested under PMKVY shall be explored. Hence, certain Polytechnics located at District head quarters and Polytechnics offering specialized branches of Engineering Courses have been identified and the Principals of these Polytechnics are hereby instructed to entrust the work of coordinating the task of studying the notification in detail, conducting a needs analysis of industry needs to a Head of Section, who shall in turn coordinate and select his/her team of domain experts from the Polytechnic to examine the notification in detail and suggest courses that can be run in their Polytechnic. They are further requested to conduct a brief needs analysis survey by talking to Industry personnel before identifying the Industry relevant courses so that placements for trainees is made easy subsequent to the training period.
