The kind attention of Principals of Govt Polytechnics concerned to the references cited. It is informed that, with change in demand for Skill workforce, the Hon'ble Chief Minister has envisioned a new paradigm in Skill Development in creating learning opportunities for the youth in sharpening their technical employability skills with particular focus on industry and market alignment.

In this regard, the Government is planning to set up the Skill Hub Centres at each Assembly Constituency level by converging Polytechnics and ITIs to enhance the skills of students and unemployed youth to create more employment opportunities as per the local industrial demand. It is further informed that the new courses as per the market demand and also courses in emerging areas, are to be started in 84 Government Polytechnics and also in new Polytechnics to be established under Convergence model in 30 Govt ITIs.

Therefore all the 84 Principals of Government Polytechnics and inspection officers as per this officer memo dated 19-03-2022 where new Polytechnics to be established under Convergence model in 30 Govt ITIs are instructed to submit the feasibility report on starting new Diploma courses in the above institutions along with filled in Proforma-A and Proforma-B to this office on or before 23-03-2022.
