ORDER:-

In the G.O. 1st read above, Government have renewed the services of Lecturers (352) and Workshop Attendants (187) (total 539 posts) working in Government Polytechnics in the State of A.P. against the vacant posts in Government Polytechnics, for a period of 3 years w.e.f. 2017-18 and also accord permission to continue the contract period for 12 months by giving 10 days break from the academic year 2019-20 to the Contract Lecturers vide G.O. 2nd read above.

2. Government after careful examination of the proposal in the letter 3rd read above, hereby accord permission to the Commissioner of Technical Education, Andhra Pradesh, Vijayawada for continuation of (352) Polytechnic Lectures and (187) Workshop attendants on contact basis for a further period of 10 months for the academic year i.e. 2020-21 from June to March (or) till regular recruitment is done by giving 10 days break, for smooth running of academic class work and administrative works in the Government Polytechnics and considering the current circumstances of COVID. The Commissioner Technical Education is also permitted 10 months of period from 1st June 2020 to 31st March 2021 (or) any other period convenient to them depending on the requirements of ensuing Academic Year.

3. The Commissioner of Technical Education, Andhra Pradesh, Vijayawada shall take further necessary action as per rules, conditions and guidelines on contract / outsourcing services issued by the Government in vogue.
