ORDER:

In the reference 5th read above, the Commissioner of Technical Education, Andhra Pradesh, Hyderabad has stated that the Teachers, Librarians and Physical Directors working in Government Polytechnics are governed by the Special Rules for A.P. Technical Education Service issued under the provision to Article 309 of the Constitution of India in G.O.Ms.No.178, Higher Education (TE.I-2) Department, dt.09.12.2005 read with G.O.Ms.No.11, Higher Education (TE.I) Department, dt.25.02.2013. The Teachers, Librarians and Physical Directors in Government Polytechnics are drawing AICTE Scales of Pay issued from time to time. Government issued orders last in the G.O.Ms.No.209, H.E (TE.I) Department, dt.20.11.2010 for implementation of the A.P. Revised AICTE Scales of pay, 2006 to the Teachers, Librarians and Physical Directors working in Government Polytechnics in the State with effect from 01.01.2006. As per Para 9 of Appendix A containing Modalities for implementation of AICTE Scales of Pay 2006 to the above G.O. cited, the age of superannuation of Polytechnic Teachers shall be 58 years on par with State Government Employees. As the age of superannuation of the Government Employees has been now enhanced from 58 to 60 years in Andhra Pradesh Public Employment (Regulation of Age of Superannuation) (Amendment) Act 2014 (Act.4 of 2014) and in G.O.Ms.No.147, Finance (HRM-IV) Department, dt.30.06.2014, the age of superannuation of Polytechnic Teachers is also required to be enhanced from the existing age of 58 years to 60 years on par with State Government Employees. In the above circumstances, the Commissioner of Technical Education, AP., Hyderabad has proposed the amendment to the G.O.Ms.No.209, Higher Education (TE-I) Department, dt.20.11.2010, so as to facilitate the Teachers, Librarians and Physical Directors working in Government Polytechnics to enjoy the benefit of enhancement of the age of superannuation from 58 to 60 years on par with State Government Employees and the CTE has requested to issue amendment to the G.O.Ms.No.209, Higher Education (TE-I) Deptt., dt.20.11.2010 at an early date.

2. After careful examination of the proposal of the Commissioner of Technical Education, Andhra Pradesh, Hyderabad, Government hereby delete the Para 9 of Appendix-A of G.O.MS.No.209, H.E (TE.I) Department, dt.20.11.2010.
