Rahull Alwar Das, 5 years Mechanical Engineering Integrated Dual Degree (BE+ME) from Andhra University College, Visakhapatnam to Sanketika Vidya Parishad Engineering College, Visakhapatnam on medical grounds for the academic year 2014-15– Permission accorded – Orders – Issued.

ORDER:

The Commissioner of Technical Education, Andhra Pradesh, Hyderabad in his letter read above has stated that S. Rahul Alwar Das, has requested for transfer from Andhra University College of Engineering (A), Visakhapatnam, (III/IV) Mechanical Engineering (5 years integrated dual degree) to Sanketika Vidya Parishad Engineering College, Visakhapatnam for (III/IV) 1st semester of 4 years B.E. Degree in Mechanical Engineering, for the academic year 2014-15, on medical grounds. He has stated that the Registrar, Andhra University, Visakhapatnam has informed that the scheme of instruction is different for 5 years (BE + ME) Integrated Dual Degree in Mechanical Engineering and 4 years BE Degree in Mechanical Engineering, but the syllabus is same upto 3rd year 2nd semester only.

2. He has also stated that there is no Government order / provision for transfer of students from one professional institution offering 5 years (BE + ME) integrated dual degree to another professional institution offering 4 years B.E. Degree in the State, and requested the Govt. to take necessary action in the matter.

3. Government after careful examination of the matter it has been observed that the 5 years integrated dual degree in Mechanical Engineering and 4 years B.E. Degree in Mechanical Engineering is same upto 3rd year, II Semester. Accordingly, Government hereby order that S. Rahul Alwar Das (5 years Mechanical Engineering Integrated Dual Degree) be transferred from Andhra University College, Visakhapatnam to Sanketika Vidya Parishad Engineering College, Visakhapatnam at IIIrd 1st semester, as a special case, and the above transfer shall not be a precedent case in future.

4. The Commissioner of Technical Education, Andhra Pradesh, Hyderabad shall take necessary further action in the matter.


