Government vide G.O.Rt.No.138, Higher Education (Technical Education) Department, dt: 09-07-2018 issued orders duly” deciding to enhance the fee structure in the Government, Aided Polytechnics and Government D.Pharmacy colleges in Private Unaided Polytechnics and Private Unaided D.Pharmacy Institution keeping in view of improving the infrastructure facilities and providing quality education to Diploma students and the annual inflation rate.

Accordingly, the enhanced fee structure is hereby ordered from the **academic year 2018-19 onwards** by the Government and Aided Polytechnics and D.Pharmacy college and Private Unaided Polytechnics and D.Pharmacy institutions imparting Diploma education in the state.

Sl.No. 1 states that : As the revised fee structure is implemented from the academic year 2018-2019, all first year students are eligible to pay an amount of Rs.50/- and Rs.300/- towards TECHFEST and MIS respectively. The students of 2nd year and 3rd year, who took admission prior to the academic year 2018-19 shall pay Rs.30/- for TECHFEST, as the G.O.138 does not applicable to those students.

Sl.No.2 states that: from the academic year 2019-20, all 1st year and 2nd year students are eligible to pay Rs.50/- and Rs. 300/- towards TECHFEST and MIS respectively. Similarly, all 3rd year students shall pay Rs.30/- towards TECHFEST only, as their admission is prior to academic year 2018-19

Further, all Government, Aided, D.Pharmacy, Aided, unaided are hereby directed to pay the respective amount as mentioned below:
