It has been observed that, some of the staff members have requested to include their higher qualifications, name corrections, and passing of accounts test details.

On verification of records, the staff members who have prosecuted Ph.D while in service and have obtained No Objection Certificates by the Regional Joint Directors of Technical Education concerned as well as Commissioner of Technical Education is considered. Further name corrections are verified as per the SSC marks Memo and passing of account tests is verified with individual hall ticket no.s which are published by APPSC in the website and also entries made in the Service Register of the incumbents is considered and incorporated in the final seniority lists.

In addition to the above, some of the Lecturers who were recruited vide Notification No. 23/2018 have requested to include their higher qualifications viz Ph.D, against their names in the Final Seniority list of lecturers in CCP, as they have completed said qualifications prior to the date of joining the Department. On verification of records, the request of Lecturers who have pursued their Ph.D prior to joining the Department is considered and updated in the Final Seniority.

It is informed that, the seniority of the Lecturers, who have been appointed through 'appointed by promotion', may vary subject to the fulfilment of the conditions as per the rules in vogue.
