6. Augmented & Virtual Reality
7. Cloud Computing
8. 3D Printing & Modelling

Eligibility Criteria:

As per the National Credit Framework (NCrF), Table 6: NCrF Levels and Credit Assignment in Vocational Education and Training/Skilling, the following criteria apply for NSQF/NCrF Level 4 entry:

1. Completion of the 2nd year of a 3-year diploma after 10th grade.
2. Currently pursuing the 3rd year of a 3-year diploma after 10th grade.
3. Currently pursuing the 1st year of a 2-year diploma after 12th grade.

Credits: Eligible for 1 credit (30 hours) under the NCrF.

Assessment: Quiz-based knowledge validation after each 30-minute pathway and knowledge check through IT-ITeS SSC NASSCOM assessment.

The implementation of this course will be carried out in the following manner:

1. **Student enrollment** : via FutureSkills Prime
2. **Course Completion:**Students are required to complete the course within **30 days** of enrollment.
3. **Skill Badges:**Students will receive skill badges after completing each module.
4. **Final Assessment:**Upon completing the 30-hour course, students will proceed with an initial assessment.
5. **Assessment Fee for NASSCOM Certification:**
An assessment fee of ₹ 600 to receive the NASSCOM certification.
Note: Payment for certification is optional and left to the student discretion.
There is **no fee** for registering or accessing the LMS content.
