1	N.M.Muthu Kumar, GPT, Rajampeta, (Sl.No.12)	He has requested to place his name at appropriate place as per the merit/ rank obtained in the APPSC	On verification of records, he is informed that, his seniority was settled long back as per the list communicated by the APPSC. As per Cir.memo.no. 57759/Ser.A/2014-1, General Administration (Ser.V) department, dt: 25.05.2004, no request for revision of seniority for a period which is more than 3 years old shall be considered. Further, the Government in Memo. No.1689432/TE.A2/2022, SD&T (TE) Dept.,dt.19.12.2022 informed the incumbent that he is not entitled for the revision of inter- se-seniority as per the rule position mentioned therein. Hence, his request is rejected
2	Dr.Ch. Moses Aravind, MBTS GP, Guntur, (Sl.No.16)	He has requested to place his name over and above Sri. G. Venkata Subbaiah as per list communicated by APPSC and initial date of joining in the cadre of Lecturer. He also requested to add higher qualification Ph.D in the seniority list.	On verification of records, Sri G. Venkata Subbaiah was repatriated from Zone-III- IV under 610.
