This is to inform that, vide ref. 1<sup>st</sup> cited, the Government issued amendment orders to the Andhra Pradesh Private Universities Establishment and Regulatory Act 2016. As per these amendment orders, 35% seats of the total intake of every course offered by Private Universities are treated as Government Quota seats and the admissions in Government Quota seats in every course have to be filled with the candidates belonging to the State of Andhra Pradesh duly following the Presidential Orders and the Rule of Reservations based on the merit among the candidates qualified through Common Entrance Tests (CETs), by the Convener (Admissions), as done in the previous academic years.

In this context, the Government has to issue the Approval Orders to 35% seats under Government Quota in various Engineering / MCA / MBA / BCA / BBA / BMS / Pharmacy courses running in the Private Universities in Andhra Pradesh, to start the CETs counselings in June / July 2025 for the admissions for the academic year 2025-26.

Hence, the Registrars of Private Universities in Andhra Pradesh are hereby requested to submit the Course-wise and Branch-wise Total Intake Details of various Engineering / MCA / MBA / BCA / BBA / BMS / Pharmacy courses offered by the Private Universities (as per the ANNEXURE enclosed) along with the soft copy of the

same to the mail address: [cteapeh2018@gmail.com](mailto:cteapeh2018@gmail.com) by 30.06.2025 in order enable the Government to complete the admissions process at the earliest.
