It is to inform that, the Government of Andhra Pradesh has initiated the **“Swachh Andhra”** program, under which the 3<sup>rd</sup> Saturday of every month is designated as Swachh Andhra day to drive systemic change and foster a cleaner, greener and healthier Andhra Pradesh. In this regard, vide reference 1<sup>st</sup> cited, detailed operational guidelines covering theme, activities & outcome for every month, stakeholders to be involved, role & responsibilities, program calendar, list of activities & areas to focus in the day of swachh Andhra, department wise activities to take up on focus areas and outcomes, timelines etc are issued.

Further, vide refence 2<sup>nd</sup> cited, Sri K. Vijaya Bhaskar, Deputy Director (A), O/o DTE, AP, is appointed as Nodal Officer to Swachh Andhra program for the Department of Technical Education, to oversee observance of activities in all Polytechnics, in line with the operation guidelines aforementioned. Additionally, vide reference 3<sup>rd</sup> cited district level nodal officers are appointed to oversee the effective implementation of Swachh Andhra Day and Swachh Andhra Program activities at every Govt., Aided, private polytechnics and D-pharmacy institutions across their district(New).

In this connection the following guidelines are reiterated/issued in addition to the operational guideline:

## 1. Observance of Swachh Andhra Day

- The Principals of all polytechnic institutions including Govt., Aided, Private, D-Pharmacy institutions are hereby instructed to mandatorily observe 3<sup>rd</sup> Saturday of every month as “Swachh Andhra Day” at their respective institutions. Further, ensure active participation of all students & staff, stakeholders in Swachh Andhra activities. The themes and activities shall align with the monthly focus areas prescribed in the operational guidelines.

## 2. Monthly Themes & Activities

Align activities with the **monthly themes** specified in the G.O.Rt.No.24 cited (e.g., January: “*New Year – Clean Start*”, February: “*Source – Resource*”).

Additionally, Key activities shall include:

- **Parent-Teacher meets:** Discuss the themes in Parent-Teacher meets on topics viz., Safe food handling, Waste segregation, Personal hygiene etc.,
- **Mass Cleanliness Drives:** Clean campuses, labs, hostels, corridors and surrounding areas.
- **Awareness Campaigns:** Organize workshops, seminars, and rallies on waste segregation, plastic reduction, and hygiene.
- **Competitions:** Conduct essay writing, poster-making, art, skit and debates on cleanliness themes.
- **Green Initiatives:** Plantation drives, water harvesting, observance of no emission day at polytechnics on the day of Swachh Andhra (3<sup>rd</sup> Saturday of every month), implementation of no litter policy, banning of plastic into campus, etc.

## 3. Institutional Responsibilities

- **Infrastructure Maintenance:** Ensure clean toilets, safe drinking water facilities, and waste segregation bins.
- **Curriculum Integration:** Include hygiene, sanitation, and environmental sustainability in student projects. Encourage students led green/ Swachh Andhra initiatives/ projects.
- **Swachh Syniks:** Form student-led clubs (similar to NCC/NSS) to drive cleanliness activities.
- **Community Engagement:** Collaborate with local ULBs, NGOs, and industries for joint initiatives.

## 4. Reporting & Documentation

**Reports:** Submit monthly activity reports to the nodal polytechnics every Monday of that month.

## 5. Compliance & Monitoring

- Nodal polytechnic principals are responsible for collecting data of the all Govt., and Private polytechnics in their nodal district.
- Top-performing institutions will be recognized at state-level events.

## 6. Key Performance indicators (KPIs) set for Technical Education Department

- All the polytechnics are instructed to adhere to the key performance indicators (KPIs) set for Technical Education Department for Swachh Andhra :: Swachh Polytechnic.
- The list of KPIs and their targets are enclosed herewith.

In this connection, Principals of all the Government/ Aided/ Private un-aided Polytechnics/ D. Pharmacy Institutions under the Departments of Technical Education, AP, are hereby comply with the above instructions.

Further, the Principals of nodal polytechnics are hereby informed to submit the monthly reports of their district, to this office through mail to [academicmedia.dte@gmail.com](mailto:academicmedia.dte@gmail.com) along with the 3 or 4 high definition Photographs taken during that month. This shall be treated as **Impetrative**.

In this connection, Regional Joint Directors of technical Education are hereby informed to promote and oversee the effective implementation of Swachh Andhra Program in all Polytechnics in their respective regions.

  - Principal Secretaries/Secretaries from, PR&RD, MA&UD, Medical & Health, Education, Industries, EFS&T, Transport, Police, I&PR, Tourism, MD SAC, Director of Municipal Administration & Director PR & RD etc., as Members
- Preparation of State-wide Action Plan for SA
- Directions for utilization of funds and allocation (SBM, 15<sup>th</sup> FC etc.,) and issue necessary/suitable directions from time to time.
- Departmental Performance review and recognitions & corrective measures as required.
- Shall also drive the SA Thematic Programs and issue necessary directions and support to the District Level Committees.

### **B. District-level Committees SA**

**D. ULB Level Committees SA**

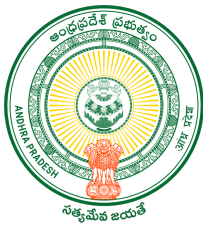
- Formation of ULB level committees headed by Municipal Commissioners and the line departments (as mentioned for State Committee) be made as Members.

**E. Gram Panchayat Level Committees SA**

- Formation of GP level committees headed by Panchayat Secretaries and the line departments (as mentioned for State Committee) be made as Members.
- The Committees formed at Mandal/ULB/GP level shall ensure implementation and monitoring etc., of the activities mentioned.
- The details of the Committees constituted and Nodal officers designated shall be submitted through the District Collectors concerned.

The Collector & District Magistrates shall act as the **KEY NODAL** officers at District Level, for the proposed programmes and to ensure every Public Office and Government Establishment participate in the monthly thematic activities, seriously.

- District Collectors shall issue suitable instructions and conduct meetings to convey the monthly theme of activities to all the reporting Department Heads at district level and ensure the success of the programme.
- Wherever inter-departmental coordination is required, suitable directions shall be issued.
- District Collectors shall also participate in the thematic activities and motivate all the departments, general public/citizens.
- On successful completion of the activity of the month review meeting on the performance to be conducted and progress to be monitored.
- Outstanding Performers to be recognized and rewarded for their contribution.

### **Departmental Nodal Officers:**

Every Department shall appoint one Departmental NODAL officer - “SA” at district level. These Nodal Officers shall report to their respective District Collectors and ensure the implementation and monitoring of the departmental & inter-departmental activities.

The Departmental Nodal officers shall also ensure that all activities are either live-cast or uploaded with relevant photos and videos on respective Social Media Handles. 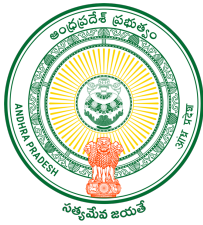

**J. Tourism Department**

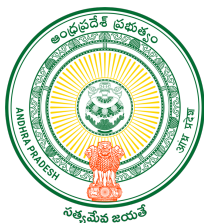
- Ensure Cleanliness & Hygiene standards at tourist destinations etc.,
