Sub: Technical Education - Establishment - APMS - Final Inter-se-Seniority list of Office Superintendents/Hostel Managers working in Government Polytechnics/ Institutions in the state for the Panel year 2023-2024 - Communicated - Reg.

Ref: This Office Cir. Memo. No. FI/502/2024, dt: 18.07.2024.

A provisional Inter-se-seniority list of Office Superintendents/Hostel Managers working in the working in the Government Polytechnics/Institutions as on 01.09.2023 for the panel year 2023-24 was communicated to the individuals concerned vide this office Memo cited, with a request to file their objections, if any, on or before 28.07.2024. In response to the Memo, the following objection has been received on the provisional inter-se-seniority list from the concerned for corrections/omissions/inclusions of their objections.

(i). Sri T.M.K. Prasad, Hostel Manager, G.M.R. Polytechnic, Yetapaka (S.No.4):

The incumbent has stated that, it has mentioned that he was awarded punishment withholding of two increments of pay without cumulative effect from 07.10.2020 on his un-authorized absence against his name in the Provisional Seniority list of Office Superintendent/Hostel Managers for the Panel Year 2023-24. But, the period of punishment is completed and eligible for promotion. Hence, he has requested to drop the remarks against his name mentioned at S.No.4.

On verification of records, the period of punishment has completed on 06.10.2022. Hence, the objection raised by the above individual is sustainable and accepted. And remarks may be dropped.

(ii). Sri M. Mani Bhooshana Rao, Office Superintendent, Dr. YSR Government Polytechnic, Kalidindi (S.No.8):

The incumbent has stated that, he was awarded punishment of withholding two increments with cumulative effect w.e.f. 31.10.2018 on irregularities in the entries made in the service register of the staff member and his total period of punishment was completed on 30.10.2022, i.e. 2+2 years of punishment period.

On verification of records, the punishment period has completed on 30.10.2022 vide G.O.Ms. No. 342, GAD (Ser.C), dated: 04-08-1997, stating that "with holding of increments with cumulative effect bars promotion or appointment by transfer twice the period for which increment is withheld' to both selection and Non Selection posts".

Hence, the objection raised by the above individual is sustainable and accepted. And the remarks against his name are dropped.

(iii). **Sri Ch. Srinivasa Rao, Office Superintendent, M.R.A.G.R. Government Polytechnic, Vizianagaram (Sl. No 23):**

The incumbent has stated that, his date of joining as office superintendent was 29.08.2013 and mentioned his name at S.No.23 instead of S.No. 22 (Sri P. Maheswara Rao). Hence, he has requested to rectify the seniority.

On verification of records, it is found that Smt. K. Nagamani (date of joining is 11.09.2013) whereas, Sri Ch. Srinivasa Rao is junior to her and his date of joining 29.08.2013 is restricted to Smt. K. Nagamani. Hence his claim may be rejected.

(iv). **Smt. P.Mary Latha, Office Superintendent, Government Polytechnic for Women, Srikakulam (S.No.34):**

The incumbent has stated that, she belongs to Scheduled Caste (SC) category, but mentioned against her name as 'Neither' in the column No.4 duly submitting the copy of caste certificate and service register. Hence, she has requested to incorporate the SC category against her name in the final seniority list of Office Superintendent/Hostel Manager for the Panel Year 2023-2024.

On verification of records it is found that the individual belongs to SC category and initially appointed as Steno Typist in limited recruitment of Backlog vacancies of SC & ST. Hence, the objection raised by the above individual is sustainable and accepted.

(v). **Sri K.S.K. Brahmeswara Rao, Office Superintendent, Government Polytechnic, Machilipatnam (S.No.44):**

The incumbent has stated that, his name has shown at Sl.No.44 with remarks stating that as private criminal case is pending in Crime. No.603/17 before the Hon'ble court 1st ACMM, Vijayawada. Further stated that he has filed a writ petition vide W.P.No. 19155/2021 praying to direct the respondents to consider his for promotion to the post of AO as per the seniority list for the panel year 2020-21 without reference to the criminal case vide Sc100/2019 on the file of the XII AD and session judge court, Vijayawada.

On verification of records, private criminal case pending in Crime No.603/17 Hon'ble I-ACMM, Vijayawada against Sri K.S.K.Brahmeswara Rao, (the then Office Superintendent, Andhra Polytechnic, Kakinada) and now working as Office Superintendent at GP, Machilipatnam City. Further, he has approached the Hon'ble High Court of A.P in W.P.No. 19155 of 2021 in view of remarks in final seniority list of 2020-21 praying the Hon'ble High Court to consider his case for promotion to the post of Administrative Officer as per his seniority for the panel year 2020-2021, for which no DPC has been convened. Further, no Interim Orders are in the Writ Petition. Further, counter affidavit has been filed in the Writ Petition. The matter is pending before the Hon'ble High Court for adjudication.

Hence, the objection raised by the individual cannot be considered.

(vi). **Smt. G. Usha Rani, Office Superintendent, Government Polytechnic, Tadepalligudem (S.No.45):**

The incumbent has stated that, in the seniority list of Senior Assistant to the post of Office Superintendents she was in the Sl.No 2

and whereas Sri KSK Brahmeswara Rao and Smt. B. Ramadevi stood at Sl.No. 7 and 10 respectively and the same anomaly was rectified in the final seniority list for the panel year 2019-20 and placed both the incumbents below her in the Sl.No. 74 and 86 respectively. Hence she has requested to rectify the anomaly.

On verification of records, it has been observed that, her name was mentioned below the name of Sri KSK Brahmeswara Rao in the promotion orders and final Seniority list of Office Superintendent/Hostel Managers communicated for the Panel Year 2021-22. Further, no objection was raised at the time of final seniority. Hence, the claim of the individual cannot be considered.

(vii). **Sri P.V. Ravi Prakash, Office Superintendent, Government Polytechnic, Anakapalli (S.No.68):**

The incumbent has stated that, he was promoted as Office Superintendent and posted at GP, Anakapalli and reported on 26.03.2021 and his service were regularized on 31.03.2021. Further he is claiming that Sri N Ramji Ambedkar, HM, GPW, Nandigama was promoted on 01.04.2021 and regularized on the same date. he was not considered for promotion vide order No. F/101/2020, dt: 24.03.2021 and requested to change his name as P.V. Ravi Prakash as it is noted as P. Ravi Prakash.

On verification of records, the claim of the individual is sustainable and accepted.

(viii). **Sri Shaik Abdul Khayyum, Office Superintendent, Government Polytechnic for women, Guntur(S.No.89):**

The incumbent has stated that, his name was wrongly entered in seniority list as Abdul Khayyum instead of Shaik Abdul Khayyum and his date of promotion in the cadre of Senior Assistant has been entered as 10.01.2013 instead of 08.01.2013.

On verification of records, the claim of the individual is sustainable and accepted.

In this connection, the provisional Inter-se-seniority list of Office Superintendents/Hostel Managers working in Government Polytechnics/ Institutions for the Panel year 2023-2024, those who are in service as on 01.09.2023 vide ref cited is finalized and the final seniority list is herewith annexed and communicated to the individuals concerned.
