Technical Education – Govt. of India initiative - Implementation of Ayushman Bharat Digital Mission (ABDM) in Polytechnics –

It is to inform that, vide reference cited, the Govt. of India has initiated the ABDM (Ayushman Bharath Digital Mission) all over India to digitalize the health records of all the citizens of India by providing a Unique Health ID and this Health ID is called ABHA (Ayushman Bharat Health Account). It is a 14-digit number. During COVID-19 the ANMs from the Department of Health and Family Welfare have created ABHAs in the door-to-door survey done to screen population for Non- Communicable Diseases (NCD). This was the first step towards digitalization of health records for on-time treatment, accessibility of health records, and sharing of health records to other health institutions within ABD compliance software with the consent of patients to treat by, knowing previous health history.

- 2. The Health and Family Welfare department has created 4.15 crores of ABHAs for citizens of AP and it has been identified that few students in the educational institutions were left out of ABHA creation. they are further interested in creating awareness for students in this matter as they are technology savvy and can be a resource to further utilize the ABHA in society.
- 3. During their recent visit to the office of the Commissioner, AP Social Welfare Residential Educational Dept. we noticed that for 1,03,499 enrolled students, 12,641 students were found without ABHA. Their office has conducted training to the concerned officers in the creation of the ABHAs to the left-over students. The same strategy shall be followed in all Polytechnics for gearing up the ABHA Creation and subsequent linking of the health records with the individual ABHA Account.
- 4. During this transition of digitalization, the ABDM team positioned at the Office of the Director of Health and Family Welfare, AP, Mangalagiri would assist by providing the required knowledge for making this digitalization drive seamlessly.
