**MINUTES OF THE MEETING HELD ON 20.01.2014 IN THE MINI  
CONFERENCE HALL OF THE COMMISSIONERATE OF TECHNICAL  
EDUCATION, A.P. HYDERABAD**

The Commissioner of Technical Education, A.P. Hyderabad held a meeting with the officials of O/o CTE, RJDs, SBTET & Principals of the (7) GMR Polytechnics in the state on 20.01.2014 in the chambers of the Commissioner of Technical Education, to review the on going schemes under SCP & TSP. The following decisions have been taken.

1. The status of implementation of the schemes was reviewed.
2. The Principals are instructed to take Photographs of the civil works before, during and after completion of the civil works for record pertaining to SCP/TSP schemes.
3. The Principals of Government Model Residential Polytechnics are permitted to procure Solar Water heaters from NEDCAP, from the funds available under improvement of hostels of GMR Polytechnics for SCs & STs.
4. The Principals of Government Model Residential Polytechnics are permitted to pay an amount of Rs 1500/-PM as honorarium to the Warden.
5. The Principals of Government Model Residential Polytechnics are permitted to submit proposals to take up Civil/Electrical works for improvement of buildings of GMR Polytechnic, under the scheme of Improvement of Hostels through RJDs concerned.
6. The Principals of Government Model Residential Polytechnics are permitted to meet the expenditure to clear off the old mess dues if any, which could not be collected from the students prior to the implementation of the schemes under SCP/TSP, from the savings available under different heads of individual benefitting schemes of SCP/TSP.
