In the reference cited, the Government has stated that the Government introduced the online system for sanction of PMS to SC, ST, BC, EBC, Minorities & Physically Challenged students during 2008-09 and it was decided to pay reimbursement of tuition fee to colleges and maintenance fee to students through their respective bank accounts and keeping in view that most of the rural areas do not have the facility of Nationalised Banks, the students are permitted to open bank accounts in RRBs (Grameena Banks) also for availing Post Matric & Pre Matric Scholarships in addition to the existing facility of opening accounts in Nationalised Banks.



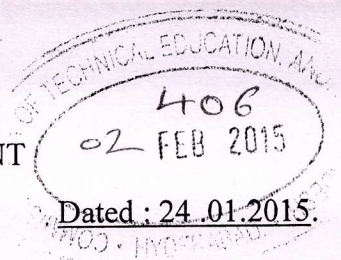

Sub:- Streamlining of Post Matric & Pre Matric Scholarships – Opening of Bank Accounts- by students in RRBs also – Permission – accorded.

In the reference 2nd read above, Government introduced the online system for sanction of PMS to SC, ST, BC EBC, Minorities & Physically Challenged students during 2008-09. It was decided to pay reimbursement of tuition fee to colleges and maintenance fee to students through their respective bank accounts.

2. For the above purpose, colleges & students shall have a bank account and they shall furnish their bank accounts at the time of registration along with the photo copy of the first page of the pass book.
3. The students can obtain no-frill Bank account or a saving Bank account from any of the Nationalised Bank, The No- frill account must be in the name of the students only.
4. In the State Level Bankers Committee (SLBC) Meeting held on 30-12-2014 some of the participant bankers from RRBs have requested the Government to permit the students to open Bank Account for the Post-matric & Pre-matric Scholarships in RRBs (Grameena Banks).
5. After careful examination of the matter, keeping in view that most of the rural areas do not have the facility of Nationalised Banks, the students are permitted to open bank accounts in RRBs also for availing Post matric & Pre matric scholarships in addition to the existing facility of opening accounts in Nationalised Banks.
6. All District Welfare Officers shall give vide publicity in the districts to enable the students to obtain a Bank Account from any of the Nationalised Banks and RRBs.
