She further requested to include the details of passing of Account Test for Subordinate Officers Part II and Account Test for Executive Officers (141) in the Final Inter Se-Seniority List of Senior Lecturers of Government Polytechnics.

On verification of the records, it is found that when the recruited notification, branch and the date of regularization is same. Then the age is criteria for fixing of seniority. In view of the above the date of regularization of Sri Y. Vijaya Bhaskara Reddy, Senior Lecturer in CCP is restricted to 30.12.1991 instead of 07.12.1991 to the date of joining of his senior as per APPSC merit list vide this office procs No. C3/32783/1995 dated: 26.07.1997 and the date of regularization of Dr. G. Rajeswari is 30.12.1991. the date of birth of Y. Vijaya Bhaskar Reddy is 16.08.1970 and the date of birth of Dr. G. Rajeswari is 10.08.1968.

In view of the above, Sri. Y. Vijaya Bhaskhar Reddy is younger than Dr. G. Rajeswari. Hence, the request of Dr. G. Rajeswari, is considered and her seniority is restored on par with her junior the same is incorporated in the final Inter-Se-Seniority list of senior lecturers in CCP.

Ms. No. 178, Higher Education (TE.I-2) Dept., dt. 09-12-2005, was communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 28-01-2017. In response to the Memo, the following objections/representations have been received on the provisional Inter Se-Seniority list from the Senior Lecturers of the Government Polytechnics for corrections/inclusions of their objections and the same disposed off as mentioned against their names.

(i) **Dr. USHA RANI JASTI, SENIOR LECTURER IN CCP, GOVERNMENT POLYTECHNIC FOR WOMEN, NANDIGAMA (S. NO. 5):**

The incumbent has stated that, she has joined in the department on 30-12-1991 as Associate Lecturer and services were regularized on 30-12-1991 and the date of regularization of Sri Y.Vijaya Bhaskara Reddy, Senior Lecturer is restricted to the date of her regularization as per the APPSC merit vide this office procs No. C3/32783/1995 dated: 26.07.1997. Hence, she requested for protection of her seniority on par with her juniors. Further she requested to incorporate her passed Account Test for Sub-ordinate Officers Part II and Account Test for Executive Officers.

On verification of the records, it is found that the regularization date of Sri Y.Vijaya Bhaskara Reddy, Senior Lecturer in CCP is restricted to 30.12.1991 instead of 07.12.1991 to the date of joining of his senior as per APPSC merit list. Hence, the request of Dr. J. Usha Rani is considered and her seniority is restored on par with her junior the same is incorporated in the final Inter-Se- Seniority list of senior lecturers in CCP.

(ii) **Dr. G. RAJESWARI, SENIOR LECTURER IN CCP, GOVERNMENT POLYTECHNIC, SRIKAKULAM (S. No. 7):**

The incumbent has stated that, she has joined in the department on 30-12-1991 as Associate Lecturer and services were regularized on 30-12-1991. She has further stated that, when the date of joining is the same for the candidates working in the various zones, the date of birth is considered for fixing the seniority, as per that rule, though the services of Sri Y.Vijaya Bhaskara Reddy, Senior Lecturer in CCP is regularized from 30-12-1991 whose date of birth is 16-08-19670, which confirms he is
