Dear Shri Tucker,

Aadhaar (Targeted Delivery of Financial and other Subsidies, Benefits and Services) Act, 2016 has come into force from 12th September, 2016. Section 7 of the Act enables use of Aadhaar as a condition precedent for services and benefits subject to the provision that no service / benefit may be denied for want of Aadhaar and by 31.3.2017 Aadhaar must be provided.

- 2. Hence, Central Sector and Centrally Sponsored Schemes of scholarships have been brought under the purview of Section 7. The Ministry of Social Justice and Empowerment has issued notification with effect from 16th February, 2017 (copy enclosed).
- 3. In accordance with the Notification, every student beneficiary should have Aadhaar or enroll for getting Aadhaar at the nearest enrolment centre by 31st March, 2017. However, Section 7 of Aadhaar Act clearly mandates that if a beneficiary does not have Aadhaar, the individual should be offered alternate and viable means of identification for delivery of benefits and for this para 3(3)(b) lists out the alternative identity proofs that may be taken from a student provided a copy of the request made for Aadhaar or the Aadhaar enrolment identity (EID) are available and taken on record.
- 4. You are, therefore, requested to ensure that an extensive drive is carried out amongst student beneficiaries of scholarship schemes administered by Ministry of Social Justice and Empowerment so that students who do not have Aadhaar, are made to enrol or apply for enrolment, as the case may be, by 31st March, 2017. It is necessary that the Aadhaar number be linked with the bank account of the beneficiary.

- 5. A proforma for capturing data on DBT for identified scholarships including details of Aadhaar enrolment was sent by letter No.5-7/2016-DBT dated 30th November, 2016 addressed to Secretaries and Commissioners of Social Welfare Departments. Now that Aadhaar is the mandated identifier for release of benefits, the information requested in the said proforma must be sent to the Ministry every month to ensure release of funds. A copy of the proforma is once again enclosed.
- 6 I would, therefore, request that before the commencement of the next academic session, all efforts may be made to enroll all student beneficiaries of the scholarship schemes as listed in the enclosed Notification.
