It is with great regret that we would like to bring to your kind notice some of the following grievances of Non-teaching staff in affiliated engineering college of Andhra Pradesh for immediate action.

Through the tuition fee fixation is done on the recommendations of AFRC to the regulation Committee keeping in view of the hike of salaries and other allowances to the staff from time to time, most of the colleges are denying the benefits and not giving the salaries and other allowances on par with the recommendations of AFRC Committee and not implementing G.Os issued by the Government from time to time.

Through the humble requests have been made by the staff of the college concerned repeatedly for implementation of the following, the Managements have not been complying and conceding to their requests.

- 1) 10th PRC is not implemented in Majority Engineering Colleges in A.P.
- 2) The Gratuity is not implemented as per gratuity act.
- 3) Age of Super annotation to 58 to 60 years as per amended AP education act.

We appeal to you to kindly consider the above grievances and issue necessary instructions to all the Managements of the engineering College for Implementation of the G.Os and other orders issued by the Govt. from time to time.

Your immediate action in this regard will be of great help to us and will be highly appreciated.
