ORDER:-

The Departmental Promotion Committee re-constituted in the G.O. 1st read above, met on 04-05-2017 and approved the names of the Eligible Assistant Directors(CTI) for promotion to the post of Deputy Director (CTI) in the O/o Commissioner of Technical Education, A.P, Vijayawada.

2. In the circumstances the following temporary promotion is made to the post of Deputy Director (CTI) in the O/O Commissioner of technical Education, A.P, Vijayawada.

NOTIFICATION

Under the provisions of Rule 10 (a) (i) of Andhra Pradesh State and Sub-ordinate Services Rules 1996 the following temporary promotions are made:

1. Sri G.Chandra Rao, Assistant Director (CTI), O/o CTE, A.P., is temporarily promoted as Deputy Director (CTI) in the O/o Commissioner of Technical Education, A.P, Vijayawada in the Scale of Pay of Rs. 46060-98440 and posted in the existing vacancy.

3. The above promotion order is subject to the final outcome of OAs/WPs/CAs pending in the Hon'ble A.P.A.T. and Hon'ble High Court and also subject to the modification orders in the revision of the ratio given by Government from time to time.
