A Provisional Seniority list of Lecturers in Pharmacy (Category 11 of Class B in APTES Rules) from Zone -I to Zone -IV in Government Polytechnics those who are in service as on 01-09-2016, prepared with reference to the Special Rules for APTES issued in GO. Ms. No. 178, Higher Education (TE.I-2) Dept., dt. 09-12-2005, was communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 10.08.2017. In response to this office Memo, the following objections/representations have been received on the provisional seniority list from the incumbents for corrections/inclusions/omissions in the seniority list. After careful examination the objections received from the incumbents, the objections are disposed off as shown against their names.

1. **P. Subha Rani (S.No.2, Zone II), Lecturer in Pharmacy, GPT, Kakinada:-** She represented that she was appointed as Lecturer in Pharmacy in Zone-II Through APCSC. Smt. MSV Sakuntala (S.No.1, Zone II) and the incumbent are the first to be recruited through APCSC in Zone-II. Smt. MSV Sakuntala was selected against roster point 1 (OC-W) and the incumbent was selected against the roster point 2 (SC-W). Meanwhile, Sri RDLP Christian was transferred from GPW Srikakulam (Zone-I) to GPW Kakinada (Zone-II) under GO. Ms. No. 610 and his services were protected from the date of joining in Zone-I i.e. 16.01.1996. Accordingly, Sri RDLP Christian, P. Subha Rani and Smt. MSV Sakuntala would have been selected against the roster points for 1-OC (W), 2-SC (W) and 3-OC. Hence, she requested to place her name above Smt. MSV Sakuntala in the seniority list.

The Seniority shall be fixed in terms of Rule 33 (a) read with the proviso to Rule 33 (b) of A.P. State and Subordinate Service Rules basing on the merit list prepared by the Appointing Authority on the basis of marks obtained without reference to the roster points. The common judgment given by Hon'ble APAT in OA No.8473 of 2011 with VMA No.1652/2012 & CA No.1936/2013 and OA No.6202/2013 on 23.04.2015 and judgment of Hon'ble High Court of AP in WP No.13052 of 2010 & Batch dated 24.01.2014 also pronounced that there is no rule, which mandates that the seniority must be determined on the basis of the points in the roster of reservation; The purpose of reservation stands served, once it is ensured that adequate representation is provided for; Beyond that, the rule of reservation has no purpose to serve and further makes it copiously clear that the marks/merit obtained by the candidates shall only be the criterion for fixing the seniority of direct recruits. Therefore, the plea of the incumbent is overruled and rejected.

2. **Dr. P. Sujatha (S.No.3, Zone-IV), Lecturer in Pharmacy, SVGPT, Tirupati:-** The incumbent represented that the APCSC did not fulfill the women's reservation as per rule 22.A of APSSSR in the selection process made against the APCSC notification No. 3/95, hence the O.A. 189/1996 was filed by her in Hon'ble APAT and the an interim relief order was issued on 09.01.1996 to keep vacant one post of Associate Lecturer in Pharmacy (Now called Lecturer). However, In the order dated 27.03.1996 in O.A. 189/1996 with VMA 62/96, Hon'ble APAT directed the respondents to appoint her as Associate Lecturer in Pharmacy. As the appointment was not done till 10.11.1999,

Hon'ble APAT ordered in CA No. 407/1996 dated 07.12.1999 to appoint her as Associate Lecturer in Pharmacy with immediate effect failing which the respondents should appear before the Hon'ble APAT on 18.01.2000. In pursuance of the orders issued by Hon'ble APAT, she was appointed as Associate Lecturer in Pharmacy in Government Polytechnic vide CTE's procs. No. C4/ 16602 / 99 dt: 12.01.2000 and joined at GPW Kadapa on 21.01.2000. Also, she represented the CTE to review her seniority but it was not considered while promotions to the post of Senior Lecturers in zone-IV during the panel year 2012-13. Further, she represented that she obtained a merit list from APPSC under RTI Act on 02.09.2016. She observed in the merit list that Smt. M. Sumathi, Senior Lecturer in Pharmacy, Sri N. Kishore Kumar, Senior Lecturer in Pharmacy and the incumbent secured 53.98, 49.19 and 59.57 marks respectively in APCSC recruitment. In view of the above, she requested to include her name below RDLP Christian who secured 60.01 marks and above Smt. M. Sumathi who secured 53.98 marks in the inter-se-seniority list of Senior Lecturers in pharmacy by reviewing her date of promotion as Senior Lecturer to 08.01.2013 on par with her juniors who promoted in the panel year 2012-13 with retrospective benefits and consider her for promotion to the post of Head of Pharmacy Section.

Her case has been examined and it is informed that in their order dated:07.12.1999 in CA. No. 407/96 with CM A No.125/96 in O.A.No.189/96 the Hon'ble APAT directed the Respondents to comply with the order in appointing her as Associate Lecturer in Pharmacy within four weeks from the date of receipt of the order. In pursuance of the said order of Hon'ble APAT, Hyderabad the incumbent was provisionally selected for appointment to the post of Associate Lecturer in Pharmacy in Government Polytechnics vide Memo No. 385/F1/1999 Dated:05/01/2000 of the Secretary APCSC, Hyderabad. Keeping in view the selections made by the commission and under the provisions of Rule (10) (a) of AP State & Subordinate Service Rules, 1996, she was appointed temporarily as Associate Lecturer in Pharmacy and posted at Government Polytechnic for Women, Kadapa in Commissioner of Technical Education Procs. No.C4/16602/1999 dated 12-01-2000. Accordingly she joined the post on 21.01.2000 and her services were regularized in the category of Associate Lecturer in Pharmacy in Zone IV w.e.f. the said date: i.e. 21-01-2000. Her seniority is regulated as per Rule (33) of AP State & Subordinate Service Rules, 1996. Therefore, her plea to give her seniority as requested by her is rejected.

The Provisional Seniority List of Lecturers in Pharmacy in Government Polytechnics those who are in service as on 01-09-2016 is finalised with the above corrections/omissions/inclusions and the final Seniority list is communicated herewith to the individuals concerned. The Seniority is however, subject to the outcome of the SLPs/W.Ps/C.As/ O.As/ MAs if any pending before the Hon'ble Supreme Court of India, High Court of AP., and Hon'ble APAT.

It is informed that the seniority of the Lecturers, who have been 'appointment by promotion', may vary subject to the fulfillment of the conditions as per the rules in vogue.

The Principals concerned are requested to communicate the Final Seniority list of Lecturers in Pharmacy to the individuals concerned duly obtaining acknowledgments from them.
