A Provisional Seniority list of Superintendents/Hostel Managers of Government Polytechnics who are in service in the category of Superintendents/Hostel Managers as on 01-09-2016, for the panel year 2016-17 prepared and communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 27-01-2017. In response to the Memo, the following objections/representations have been received on the provisional seniority list from the concerned staff members through the Principals of concerned Polytechnics for corrections/inclusions of their objections.

1. Sri C.Aslam Basha, Office Superintendent, Government Polytechnic for Minorities, Kurnool:- The incumbent requested for inclusion his name in the Final Inter-Se Seniority list of Superintendents/Hostel Managers as he was promoted as Administrative officer in the panel year 2015-16 and posted at Government Polytechnic, Vempalli vide this office Proc.No.C1/8118/2015,Dt:29/06/2016. Further the incumbent sent his not willingness to assume the charges of Administrative Officer at Govt.Poly, Vempalli due to his personal problems and requested to treat it as he declined promotion to the post of Administrative Officer for the first time in the panel year 2015-16.

On verification of records it is found that the incumbent was given promotion during the panel year 2015-16 and posted as Administrative Officer at Government Polytechnic, Vempalli vide this office Proc. No. C1/8118/2015,Dt:29/06/2016. But he declined his promotion and not joined as Administrative Officer at Govt. Poly, Vempall during the panel year 2015-16. In view of the above and rules in vogue, the request of Sri C.Aslam Basha, Office Superintendent is considered and his name is included in the Final Inter-Se-Seniority list at Sl.No.05 for the panel year 2016-17.

2. Sri M.R. Sri Hari, Office Superintendent, Govt.Poly, Obulavari Palli(Sl.NO.8):The incumbent in his representation stated that, he was re instated into Service after suspension vide CTE's Proc.No F-3/4273/2017,Dt:02/08/2014 in the same capacity at Government Polytechnic, Obulavari Palli after imposed of penalty of withholding of one increment with cumulative effect. He further stated that, the period of 02 years is lapsed as on 14/08/2016 and he is eligible for promotion to the post of A.O/H.S. In view of the above he requested to consider his name for promotion in the panel year 2016-17.

On verification of records it is found that, Sri M.R Sri Hari Office Superintendent, Government Polytechnic, Obulavari Palli was suspended vide this office Proc.No FI-3/4723/2012, Dt:31/03/2012 for tampering of attendance register many times by marking himself as On Duty and he has not produced the evidence for the bank remittance of Rs 11750/-. No details were produced for the fee collected from (61) students and thus violated Rule (3) of APCS (Conduct Rules), 1964.Further Sri M.R

Sri Hari Office Superintendent, Government Polytechnic, Obulavari Palli submitted his explanation, but the explanation was found unsatisfactory. In view of the above, Sri B.Suryudu, Regional Joint Director of Technical Education, Tirupathi conducted enquiry on the matter, Sri M.R Sri Hari was awarded punishment on basis of the report submitted by the RID TE, Tirupathi "with-holding of one increment with cumulative effect" vide this Office Proc.No FI-3/4273/2012, Dt:02/08/2014 duly revoking the suspension order issued earlier and posted in the same capacity at Government Polytechnic, Obulavari Palli.

In view of the above facts, the request of Sri M.R Sri Hari Office Superintendent, Government Polytechnic, Obulavari Palli is considered and the same is incorporated in the Final Inter-Se -Seniority list Superintendents/Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

3. Sri M. Venkateswarlu, Hostel Manager, Govt. Polytechnic, Nellore(SI.No25):-
The incumbent has requested to correct his date of regularization in the category of Typist as 22.9.1988 instead of 12.11.1990 as mentioned in the Provisional Inter-se-seniority-list. Further he requested for notional promotion in the category of Typist with effect from 08.12.1981 as per the orders of Administrative Tribunal and raise his seniority in the category of Typist and show his seniority at Sl. No. 1 ahead of all other Office Superintendents/Hostel Managers in the Seniority-list.

His request to revise his seniority in the category of Typist and place him above all the Office Superintendents/ Hostel Managers shown in the Seniority-list of Office Superintendents/Hostel Managers has been verified with the records. It is observed that the notional promotion in the category of Typist with effect from 08.02.1981 is not possible now hence his request of placing him above all the Office Superintendents in the Seniority-list cannot be considered now and the same is, therefore rejected.

As per his request and on verification of records, his date of regular appointment to the post of Typist is corrected as 22.09.1988 instead of 12.11.1990 in the final Seniority-list.

4. Sri S.Mahabob Sahab, Office Superintendent, ESC Government, Polytechnic, Nandyal(SI.No.29):- The incumbent has requested to correct his place of working as ESC Government Polytechnic, Nandyal instead of Government Polytechnic for Minorities Nandyal.

On verification of records it is found that, the incumbent transferred from GPM Karnool to ESC GP Nandyal in the General Transfers 2016. Hence, the request of the incumbent considered and the same is incorporated in the Final Seniority list of Superintendents/Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

5. Smt. K.L.N Ramani, Office Superintendent, Government Polytechnic, Atmakur(SI.No.31): The incumbent has requested to correct his place of working as Government Polytechnic, Atmakur instead of Government Polytechnic for Minorities, Guntur.

On verification of records it is found that, the incumbent transferred from Government Polytechnic for Minorities Guntur to Government Polytechnic, Atmakur in the General Transfers 2016. Hence, the request of the incumbent considered and the same is incorporated in the Final Seniority list of Superintendents/Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

6. Sri K.Sudhakar, Hostel manager, Government Polytechnic, Ananthapur (Sl.No.33) :-The incumbent has requested to correct his date of regularization in the cadre of Senior Assistant as 19/08/1998 instead of 03/09/1998.

On verification of records the plea of Sri K.Sudhakar, Hostel manager, Government Polytechnic, Ananthapur is considered and his date of regularization in the cadre of Senior Assistant is corrected as 19/08/1998 instead of 03/09/1998 and the same is incorporated in the Final-Inter -Se Seniority list of Superintendents/Hostel Managers in the state of Andhra Pradesh for the panel year 2016-17 for promotion to the post of A.D/1.A.O/A.O/H.S.

7. Sri G.V.Salapasree, Office Superintendent, Government Polytechnic, Adoni(Sl.No.34):- The incumbent has requested to protect her seniority over Sri K.Sudhakar, Hostel manager, Government Polytechnic, Ananthapuramu as he is junior to the incumbent.

On verification of records it is found that, the request of the incumbent is not feasible to consider, the date of joining of Sri K.Sudhakar as Senior Assistant is 19.08.98 and as Hostel manager is 03.10.11 and the joining dates of Sri G.V.Salapasree as senior assistant is 03.09.98 and as Office Superintendent is 06.10.11. Hence, the plea of Sri G.V.Salapasree is here by rejected.

8. Sri B.Viswanatha Reddy, Office Superintendent, S.G.P.R. Government Polytechnic, Kurnool(Sl.No.45): The incumbent has raised his objection on the Provisional Inter-Se-Seniority list communicated by this office stating that, the Office Superintendents who are shown in the Provisional Inter Se-Seniority list from Sl. No 37 to 44 are most juniors to him as they are promoted in the year 2005, 2006 respectively and his promotion to the post of Senior Assistant was 1999. Hence he requested to protect his seniority and place him in the appropriate place in the Final Inter Se-Seniority list for the panel year 2016-17.

On verification of records it is found that, the Junior Assistant and Senior Assistant posts are District posts. Sri B.Viswanatha Reddy, Office Superintendent claiming his seniority on the other district Junior and Senior Assistants, his objection is over ruled. Hence, his plea is rejected here with.

9. Sri M.Ramakrishnuudu, Office Superintendent, Government Polytechnic, Alur: The incumbent has requested for inclusion of his name in the Final-Inter -Se -Seniority list of Superintendents/Hostel Managers for promotion to the post of A.D/1.A.O/A.O/H.S for the panel year 2016-17.

On verification of records, the plea of the incumbent for inclusion of his name in the Final Inter -Se -Seniority list of Superintendents/Hostel managers for the panel year 2016-17 is considered and the name of Sri M.Ramakrishnuudu, Office Superintendent, Government Polytechnic, Alur is incorporated in the Sl.No.53 in the Final Inter -Se-Seniority list of Superintendents/ Hostel managers for promotion to the post of A.D/1.A.O/A.O/H.S for the panel year 2016-17.

10. Sri B.Venkateswarlu, Office Superintendent, Government Polytechnic, Ananthapuramu: The incumbent has requested for inclusion of his name in the Final-Inter -Se -Seniority list of Superintendents/Hostel Managers for promotion to the post of A.D/1.A.O/A.O/H.S for the panel year 2016-17.

On verification of records, the plea of the incumbent for inclusion of his name in the Final Inter -Se -Seniority list of Superintendents/Hostel managers for the panel year 2016-17 is considered and the name of Sri B. Venkateswarlu, Office Superintendent, Government Polytechnic, Ananthapur is incorporated at Sl.No.55 in the Final Inter -Se-Seniority list of Superintendents/ Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

11. Sri S.Kesavulu Naidu, Office Superintendent, Government Polytechnic for Women, Kadapa: The incumbent has requested for inclusion of his name in the Final-Inter -Se -Seniority list of Superintendents/Hostel Managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

On verification of records, the plea of the incumbent for inclusion of his name in the Final Inter -Se -Seniority list of Superintendents/Hostel managers for the panel year 2016-17 is considered and the name of Sri S.Kesavulu Naidu, Office Superintendent, Government Polytechnic for Women, Kadapa is incorporated in the Sl.No.56 in the Final Inter -Se-Seniority list of Superintendents/ Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

12. Sri P.Maheshwa Rao, Office Superintendent, G.M.R.Polytechnic, Yetapaka: The incumbent has requested for inclusion of his name in the Final-Inter -Se -Seniority list of Superintendents/Hostel Managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

On verification of records, the plea of the incumbent for inclusion of his name in the Final Inter -Se -Seniority list of Superintendents/Hostel managers for the panel year 2016-17 is considered and the name of Sri P.Maheshwa Rao, Office Superintendent, G.M.R. Polytechnic, Yetapaka is incorporated at Sl.No.57 in the Final Inter -Se-Seniority list of Superintendents/ Hostel managers for promotion to the post of A.D/I.A.O/A.O/H.S for the panel year 2016-17.

It is to submit that, the Provisional Inter -Se-Seniority List is finalised with the above rectifications of errors / Objections/inclusions and the Final Inter-Se- Seniority List of Superintendents/Hostel Managers of Government Polytechnics in the state of Andhra Pradesh who is in service as on 01-09-2016 for promotion to the post of Assistant Director/Internal Audit Officer in the Directorate and Administrative Officer/Hostel Superintendent at the mufisil level is finalised and the same is communicated herewith to the individuals concerned.
