A Provisional Seniority list of Senior Lecturers in Civil Engineering (Category 3 of Class B in APTES Rules) in Government Polytechnics those who are in service as on 01-09-2016, prepared with reference to the Special Rules for APTES issued in GO. Ms. No. 178, Higher Education (TE.I-2) Dept., dt. 09-12-2005, was communicated to the individuals concerned vide this office memo 1st cited, with a request to file objections, if any, on or before 25-01-2017. In response to this office Memo, the following objections/representations have been received on the provisional seniority list from the incumbents for corrections/inclusions/omissions in the seniority list. After careful examination the objections received from the incumbents are disposed off as shown against their names.

(i) Dr. K. LAKSHMIPATHI, SENIOR LECTURER IN CIVIL ENGINEERING, GPW, HINDUPUR (S. NO. 16):

The incumbent in his representation has stated that, he was appointed as Associate Lecturer in Civil Engineering through APPSC in the year 1996 and reported for duty on 27.11.1996. He further submitted that as per the information furnished by the APPSC under RTI Act he secured 71.25 marks and Sri. M.R. DheerendraBabu secured 76.92 marks and Dr. P. Sujatha secured 70.32 marks. On the basis of the information furnished by APPSC he is the senior to Dr. P. Sujatha who was promoted to the post of Senior Lecturer in the panel year 2012-13 and the incumbent was promoted in the next panel year 2013-14. The incumbent further submitted that the seniority list of lecturers in Civil Engineering was not prepared on basis of the rank/merit obtained by the candidates which is against to the rule 33 & 36 of APSSR 1996 and also the Law laid down by the Hon'ble Supreme Court reported in (5) SSC 604 bimleshtanwar vs state of Haryana and also in W.P.No. 12237/2001 and 12238/2001 dated: 28.06.2001 also in O.A.No. 5303/2007 and O.A.No.7725/2010 dated: 19.03.2013 here in held that the roster point has no relevance for fixation of seniority and merit cum marks or the rank criteria.

Further, Dr. K. Lakshmipathi has represented that, his name was shown at S.No. 16 below the name of Dr. P.SujathaS.No. (14)in the provisional seniority list of Senior Lecturers of Civil Engineering communicated vide ref 1st cited, as both were appointed in the same recruitment batch in the same year. He further submitted that she secured less marks (70.32) than him (71.25), and got promotion ahead of the incumbent due to erroneous fixation of seniority in the cadre of lecturer which was contrary to the Rule 36(1) and Rule 33 (b) of A.P State and Subordinate Service Rules 1996.Hence, the incumbent has requested to place his name in the Seniority list at S.No. 15 beforeDr. P.Sujatha and below Dr. M. R. DheerendraBabu (S. No. 14) in respect of Zone –IV as per the rules.

Further, Dr. K. Lakshmipathi Senior Lecturer in Civil Engineering has requested to include his passing details of Account test of subordinate officers' Part II (10) and his M.Tech (Structural Engineering) degree I Class with Distinction.

With reference to the objection raised by the above incumbent it is to inform that, the appointment orders were issued based on the list communicated by the appointing authority i.e., APCSC/APPSC. The list can't be altered unless until the appointing authority submits the reviewed list. Further it is informed that the Government have issued orders by cir.memo no. 57759/Ser.A/2014-1 General administration (Ser.A) department 25.05.2004 is as follows:

"Government directs that in dealing with cases for fixing the seniority the procedure and the rules prescribed in APSSR rules or in special rules Governing the post shall be followed. No request for revision of seniority for a period which is more than 3 years old shall be considered. The seniority list in each category shall be communicated, as and when the employee completes the prescribed period of probation in the respective category".

Further it is informed that the same list is followed during the promotions given to incumbent while promoting him as Senior Lecturer. Hence, the request of the incumbent for restoration of his seniority over Dr. P. Sujatha Sr. Lecturer in Civil cannot be considered. Hence his plea is rejected.

On verification of certificates, the request of the incumbent to include the passing details of his account test of Subordinate Officers Part II (10) and M.Tech (Structural Engineering) in I Class with Distinction is considered and the same is incorporated in the final seniority list of Senior Lecturers in Civil Engineering.

(ii). DR. M.R. DHEERENDRA BABU, SENIOR LECTURER IN CIVIL ENGINEERING, GOVT. POLY, SATYAVEDU (S. NO. 15):

The incumbent has requested to review the seniority of senior lecturers based on the merit obtained by the APPSC (or by reviewing the DPC held for the previous panel year 2012-13 in the existing vacancies) and preponing the date of his promotion to the post of Senior Lecturer before the date of promotion of Smt P. Sujatha, and place him at S.No. 14 before Smt P. Sujatha and below Sri S. Srinivasa Reddy, (S.No.13)in the provisional Seniority list of Senior Lecturers in Civil Engineering communicated by this department vide reference 1st cited.

With reference to the objection raised by the above incumbent it is to inform that, the appointment orders were issued based on the seniority list communicated by the appointing authority i.e., APCSC and the list can't be altered unless until the appointing authority submit the reviewed list. Further it is informed that the Government have issued orders by cir. Memo no. 57759/Ser.A/2014-1 General administration (Ser.A) department 25.05.2004 is as follows:

<u>"Government directs that in dealing with cases for fixing the seniority the</u> <u>procedure and the rules prescribed in APSSR rules or in special rules Governing the post</u> <u>shall be followed. No request for revision of seniority for a period which is more than 3</u> <u>years old shall be considered. The seniority list in each category shall be</u> <u>communicated, as and when the employee completes the prescribed period of probation</u> <u>in the respective category".</u>

Further it is submitted that the same list is followed for considering the promotions from cadre lecturer to senior lecturer. Hence, the request of the incumbent for restoration of his seniority over Dr. P. Sujatha Sr. Lecturer in Civil is not feasible to consider. Hence his plea is here with rejected.

(III). SRI G. DAMODARA RAO, SENIOR LECTURER IN CIVILENGINEERING, GMR PLOYTECHNIC, PADERU (S.NO.6):

The incumbent has requested to correct his name as G. DAMODARA RAO instead of G. DAMODHAR RAO and also requested to make corrections of his educational qualification as B. E I Class with Distinction, M. Tech I Class instead of B.Tech1stclass and M.Tech1st class and also incorporate of his Account Test passing details in the Seniority list.

On verification of records, the request of the above incumbent for correction of his name is considered and corrected his name as G. DAMODARA RAO instead of G. DAMODHAR RAO and corrected his educational qualification as B.E I Class with Distinction, M. Tech I Class instead of B.Tech 1st class and M.Tech 1st class and also incorporated his Account Test passing details in the seniority list.

(iv) Dr. MAHAMOOD, SENIOR LECTURERIN CIVIL ENGINEERING, SVGP, TIRUPATI (S.No. 11):

The incumbent has requested to place his name at S.No. 9 instead of S.No. 11, i.e., before to Sri B. V. Ramana Prasadand to Dr. S.R. Lakshimi Prasad and below Sri P. Guru Murthy Reddy (S. No. 8) in the seniority list, as he is the merit candidate in the APPSC merit list with 175.5 marks. Whereas, the other incumbents, Sri B. V. Ramana Prasad, Dr. S. R. Lakshmi Prasad who were appointed in the same recruitment have secured marks i.e., (164.5) and (151.0) respectively. He has further requested to fix the seniority as per the rank / merit interms of the merit obtained in the recruitment process by the APPSC but not as per the roaster point, as it is contrary to Rule 33 and 36 of AP State and Subordinate Service Rules 1996 and Law laid down by the Hon'ble Supreme Court reported in 2003 [5] SCC 604 BimleshTanwar Vs State of Haryana vide W.P. No. 12237/2001 and W.P. No. 12238/2001, dt: 28-06-2001 also vide O.A. No. 5303/2007 and O.A. 7725/2010, dt: 19-03-2013.

Further, Dr. Mahamood, Senior Lecturer in Civil Engineering requested to make correction of his date of joining as 09-03-1995 instead of22-03-1995in the cadre of Lecturer and also in the cadre of Senior Lecturer as 09-01-2013 instead of <u>09-01-2013/18-01-2013</u>

With reference to the objection raised by the above incumbent it is to submit that, the appointment orders were issued based on the seniority list communicated by the appointing authority i.e., APCSC and the list can't be altered unless until the appointing authority review the list. Further it is submitted that the Government have issued orders by cir.memo no. 57759/Ser.A/2014-1 General administration (Ser.A) department 25.05.2004 is as follows:

<u>"Government directs that in dealing with cases for fixing the seniority the</u> procedure and the rules prescribed in APSSR rules or in special rules Governing the post shall be followed. No request for revision of seniority for a period which is more than 3 years old shall be considered. The seniority list in each category shall be communicated, as and when the employee completes the prescribed period of probation in the respective category".

Further it is submitted that the same list is followed for considering the promotions from cadre lecturer to senior lecturer. Hence, the request of the incumbent for restoration of his seniority over B. V. Ramana Prasad and to Dr. S.R. Lakshimi Prasad Sr. Lecturer in Civil is not feasible to consider. Hence his plea is here with rejected.

On verification of records, the request of the above incumbent for correction of his date of joining as 09-03-1995 instead of 22-03-1995 in the cadre of Lecturer and also in the cadre of Senior Lecturer as 09-01-2013 instead of <u>09-01-2013/18-01-2013</u> is not feasible to considered as his date of joining is restricted to the date of joining of his senior. Hence, his plea is here with rejected.

2. The provisional Seniority List of Senior Lecturers in Civil Engineering of Government Polytechnics in Zone I to IV as on 01-09-2016 is finalised with the above corrections/omissions/inclusions and the final seniority list is communicated herewith to the individuals concerned. The Seniority is however, subject to the outcome of the SLPs/W.Ps/C.As/ O.As/ MAs if any pending before the Hon'ble Supreme Court of India, High Court of AP., and Hon'ble APAT.

3. The Principals concerned are requested to communicate the final seniority list of Senior Lecturers in Civil Engineering to the individuals concerned duly obtaining acknowledgments from them.
