ORDER

In the reference 3rd and 5th read above, the Commissioner of Technical Education, A.P. The CTE has requested the Government to issue final seniority list of Heads of Sections in Engineering and Non - Engineering as on 01.09.2021 for the panel year 2021-22 as to effect promotions to the post of Principal.

2. The objections raised by certain individuals on the provisional seniority list, have been taken into consideration based on the remarks offered by the Commissioner of Technical Education on each of the objection and has come to the conclusion, as indicated at Annexure – I of this G.O.

3. In view of the circumstances mentioned above, Government after careful examination of the matter, hereby finalize the seniority lists of Heads of Sections for the panel year 2021-22 which are appended to this order as Annexures–II (Engineering) and Annexure-III (Non-Engineering) for effecting promotions to the posts of Principals in Government Polytechnics.
