ORDER:

In the reference 2nd read above, the Special Commissioner of Technical Education, Andhra Pradesh Vijayawada has submitted the proposals for inter-state transfers of certain lecturers / Sr. Lecturers working in Government Polytechnic Colleges from State of Andhra Pradesh to the State of Telangana under mutual basis.

3. In the reference 3rd read above, Govt. of Andhra Pradesh have issued NOC for transfer of 45 individuals (spouse grounds-6, mutual grounds same subject-16 and mutual with different subjects-23), and requested the Government of Telangana for NOC.

4. In the reference 4th read above, Government of Telangana have informed that they have "No Objection" for inter-state transfers of lecturers / Sr. Lecturers working in Govt. Polytechnic Colleges from State of Andhra Pradesh to the State of Telangana under mutual basis(with same subject) except Smt. Vasantha kumari Garbhapu, Lecturer in Computer Engg., GMRP, Gajwel as she withdrawn her application for inter-state transfer from the State of Telangana to Andhra Pradesh.

5. In the reference 5th read above, Govt. of Telangana have issued orders for inter-state transfer of lecturers / Sr. Lecturers working in Government Polytechnic Colleges between Andhra Pradesh and the State of Telangana under mutual basis(with same subject) except Smt. Vasantha kumari Garbhapu, Lecturer in Computer Engg., GMRP, Gajwel as she withdrawn her application for inter-state transfer, from the State of Telangana to Andhra Pradesh.
