**ORDER:**

In the reference 2<sup>nd</sup> read above, many of the Principals of Government Polytechnics have requested the Director of Technical Education to arrange the latest equipment/machinery as per the C-20 Curriculum and submitted the requirements of Latest equipment/ machinery as per the C-20 Curriculum for each laboratory.

In view of the above, the Director of Technical Education has decided that the Polytechnics should have to be equipped with Desktop Computers in all the institutions to fulfill the deficiency raised by AICTE for getting NBA.

Hence, the Principals of all Government Polytechnics were permitted to procure the number of Desk top Computers with the following configuration/ price for each Desktop computer system is Rs.65,000/- and directed all the Principals of Government Polytechnics to initiate the procurement procedure through GeM portal and meet the required expenditure for the said purpose from funds provided by SBTET, A.P. vide ref(6) read above.

- "12th Generation Intel Core i3-12100 (3.3 GHz or above), Windows 11 OS, 8GB DDR4-RAM, 512 GB SSD, Integrated Graphics Card, 19.5 inch LED Monitor, Multimedia Keyboard, Optical Mouse".

Accordingly, most of the Principals of Government Polytechnics have procured the Desktop Computers through GeM Portal from the funds provided by the SBTET, AP and submitted compliance report except the Principals of the certain Government Polytechnics due to some technical issues and requested the Director of Technical Education, AP to kindly permit them to procure Desktop Computers through GeM Portal from the nearby Government Polytechnics to fulfill the deficiencies raised by the AICTE.

In view of the above circumstances, the Principals of following Government Polytechnics (shown in column No. 2) are permitted to initiate procurement process of Desktop Computers for the number as mentioned in the column no. 3 through GeM Portal from the nearby Government Polytechnic as mentioned in the column no. 5 from the funds provided by the SBTET, AP and submit compliance report.
