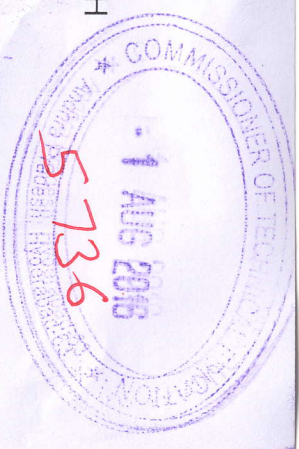

Krishna Pushkarams 2016 – Closure of Private / Government Educational Institutions situated in Krishna district – Orders – Issued.

ORDER :

In the reference cited the Collector & District Magistrate, Krishna, informed that Krishna Pushkarams, 2016 are notified from 12.08.2016 to 23.08.2016 and 3.5 crore pilgrims are expected to visit the district. They are planning to utilise the existing amenities of Private / Government Educational institutions for accommodation to staff and other prior arrangements for Pushkarams. Hence requested orders for closure of Private / Government Educational Institutions from 08-08-2016 to 25-08-2016 situated in the limits of Vijayawada Municipal Corporation and in all Mandals where Pushkaram Ghats are located.

2. After careful examination of the matter, Government hereby direct that all the educational institutions in the limits of Vijayawada Municipal Corporation and all Mandals where Pushkaram Ghats are located may be closed down by the Collector & District Magistrate to the extent necessary, from 12.08.2016 to 23.08.2016 where the Krishna Pushkarams, 2016 take place, specially mentioning names of the educational institutions.
3. It is also directed that these educational institutions should make up the working days lost by compensating in subsequent months and this shall be monitored regularly by the Heads of the department concerned.
4. The District Collector, Krishna and the Heads of Departments concerned shall take further action accordingly.


