With the references to the 1<sup>st</sup> and 2<sup>nd</sup> cited, the teaching faculty/Physical Directors/Librarians who are drawing AICTE 2016 Pay scale should complete following Mandatory Teacher trainings as specified Para 3.0 of Appendix - A and Para 4.3 (3), 4.4 (3), 4.5(3), 4.5.1(3), 4.5.2 (3), 4.5.3 (4), 5.6.2(b)(iii), 5.6.3 (b)(iv), 5.7.1(3)(iii), 5.7.2 (f), and 5.7.3 (e) of the G.O.2<sup>nd</sup> Cited for award of CAS/Promotion.

**2. The Para 3.0 Mandatory Teacher Trainings of Appendix-A of the G.O. 2<sup>nd</sup> Cited read as follows:**

- a) Every teacher appointed/promoted to any position here onwards with effect from the publication of this Government orders shall have to mandatorily undergo 8 online modules of MOOCs in SWAYAM as per the AICTE teacher training policy preferably within first year of service
- b) No newly appointed faculty member shall be completing the probation without getting the certification of completion of these 8 modules. The teacher training policy document may be downloaded from AICTE website.
- c) The requirement of completing these modules as envisioned in this gazette is applicable to all the incumbent teachers also while applying for promotion/selection to next higher cadre only once in the career.
- d) The requirement of completing these modules, however, shall be permitted to be fulfilled till 31<sup>st</sup> July 2022 (Extended by AICTE up to 31<sup>st</sup> July 2024Vide ref 3<sup>rd</sup> cited) so as to enable faculty members in equipping them for requisite mandatory requirements of this AICTE gazette to avail the benefit of promotion retrospectively from the date of eligibility.

**3. The Para 4.3 (3), 4.4 (3), 4.5(3), 4.5.1(3), 4.5.2 (3), 4.5.3 (4), of the Appendix- A of the G.O 2<sup>nd</sup> cited read as follows:**

One week faculty development programme recognized by /UGC/TEQIP/NITTTR/Pandit Madan Mohan Malviya National Mission on Teachers and Teaching (PMMNMTT)/IISc/IIT/University/ Govt and one eight weeks duration MOOCs course with E-Certification by NPTEL-AICTE.

**OR**

Completed two such eight weeks duration MOOCs courses with E-Certification by NPTEL-AICTE.

**4. The Para 5.6.2(b)(iii), 5.6.3 (b)(iv), 5.7.1(3)(iii), 5.7.2 (f), and 5.7.3 (e) of the Appendix- A of the G.O 2<sup>nd</sup> cited read as follows:**

For Librarians /Physical Directors, taken / developed one MOOCs Course in the relevant subject (with e-certification) for each movement of up gradation through CAS/Promotion as per G.O 2<sup>nd</sup> Cited.

In this Context, the Principals of all Government Polytechnics are permitted to allow teaching faculty/ Physical Directors /Librarians working in Government Polytechnics under the administrative control of the CTE, AP Mangalagiri, as per their requirement without giving any additional leave /on duty or without disturbance to normal routine duties and assigned works by Principal/CTE/SBTET and no financial commitment. Mere completion of duration of course is not the criteria, the staff should produce completion certificate as per MOOCs course eligibility by attaining minimum required score and accordingly the Principals also verify the certificates thoroughly submitted by the individuals and if found correct then only enter into their service registers.
