In the reference 3<sup>rd</sup> cited, it is informed that the Director of Technical Education, AP has conducted review meetings with the Principals of Government Polytechnics, applied for National Board of Accreditation (NBA) in order to assess the qualitative and competitiveness of the Diploma Level Programs offered by the Polytechnics from 06.02.2023 to 09.02.2023 at the office of Director of Technical Education, Mangalagiri. During the review meetings, the Principals of various Government Polytechnics have requested the Director of Technical Education to accord permission to utilise the available Non Govt. funds of the institution and additional required funds from SBTET, AP to pay the accreditation fees for submitting SAR and to purchase lab equipment and infrastructure facilities to fulfil the deficiencies/ required parameters in order to get the National Board of Accreditation (NBA) to the Government Polytechnics.

In this connection, it is submitted that the powers were already delegated to the Principals of Government Polytechnics towards purchase of required machinery and equipment and other items from the available Non-Government funds of the institutions vide this office circular memo under reference 1<sup>st</sup> and 2<sup>nd</sup> cited above.

Further the Director of Technical Education is hereby permitted the Principals of Government Polytechnics mentioned in the annexure to procure the machinery/equipment, NBA accreditation fee from the funds provided by the SBTET, AP and also to utilise available Non-Government funds of the institutions to fulfil the deficiencies/ required parameters to get the National Board of Accreditation (NBA) to the Government Polytechnics.
