

ORDER:

In the reference first read above, orders were issued approving the names of Heads of Sections for promotion to the posts of Principals in Government Polytechnics in the State of A.P. for the panel year 2016-2017.

2. In the reference second read above, the Special Commissioner of Technical Education, A.P., has furnished proposals for posting of certain Heads of Sections on Promotion as Principals and requested the Government for issue of orders.

3. Government after careful examination, hereby promote the following Heads of Sections of Government Polytechnics as Principals in the Scale of Pay of Rs.37400 -67000 (AICTE Scales of Pay, 2006) with all usual allowances applicable from the date of taking charge, purely on temporary basis, under rule 10 (a) of the Andhra Pradesh State and Subordinate Services Rules.

4. All the promotions ordered below shall be subject to the outcome of various R.Ps/O.As/W.Ps/C.As/CCs. etc. if any, pending in Hon'ble Andhra Pradesh Administrative Tribunal and Hon'ble Andhra Pradesh High Court.
