Sub: Special Summary Revision of Electoral Rolls, 2020 – Pre-revision activities – Launching of Electors' Verification Programme for authentication of electors details on 01.09.2019 - Reg.

The Election Commission of India has announced the Special Summary Revision of Photo Electoral Rolls with reference to 01.01.2020 as the qualifying date. As a pre-revision activity, the Commission is going to launch Electors' Verification Programme on 01.09.2019. All the citizens / electors may come forward and authenticate existing elector's details relating thereto, by giving copy of one of the following documents:

- a. Indian Passport
- b. Driving License
- c. Aadhar
- d. Ration card
- e. Identity Card for Government/Semi-Government officials.
- f. Bank Passbooks
- g. Farmer's Identity Card
- h. Any other document as approved by the Commission.

2. The citizens can verify their electoral details through "Voter helpline" mobile app, NVSP portal, by visiting Common Service Centres (CSCs) or submitting a hard copy of filled up forms through BLOs to EROs. During EVP the citizens / electors can give information on Family Members, details of un-enrolled / dead / shifted electors / prospective electors in the family, information about polling station and geo-tagging the house with mobile app. Following procedure would be followed during authentication of details of an elector:-

- a) If any discrepancy is noticed in the elector's detail, automatic Form 8 will be generated for correction of entries and correct details will be submitted through Form-8.
- b) In case of Dead/shifted members, facility of automatic generation of Form-7 would be provided. Form-7 would be filled by a near relative/family member (the applicant along with Form- 7 will also submit a statement intimating that he/she is a near relative/family member of the deceased elector).


- c) For registration, un-enrolled eligible elector will be given facility of filling up of Form-6.
- d) PWD electors will be given facility through Voter helpline No. 1950 to give their details.

3. In this connection, it is decided to establish a Facilitation Centre at A.P.Secretariat Association on 03.09.2019. The General Administration (OM) Department is, therefore, requested to issue necessary permission and also issue necessary instructions to all the Departments of Secretariat to encourage the employees to come forward to authenticate their and their family members electoral details through the methods mentioned above.
