ORDER:-

This is to inform that vide ref. 1st cited, the Manager (HR & Admin), KIA, Ananthapuramu stated that Kia India manufacturing unit located at Penukonda (Anantapur district) have already trained around 4387 candidates and offered job around 3000 candidates. Now interested in hiring around 1200 Diploma students (passed out & students waiting for results) for training. The interested student has to undergo online aptitude test, if he gets qualified then needs to undergo 3 days Basic Technical Course at one of the Kia Training Centers located in Govt. Polytechnic, Anantapur, or in Penukonda. The successful candidates in the basic training will be absorbed in Kia India under NEEM category and the details of training and job role are as follows:

Job Role	NEEM Trainee (Work on the assembly production line of a vehicle)
Age	19 ~ 25 Years
Branch	Any branch can apply (Except Agriculture)
Stipend	15,000 per month (Revised every year)
Gender	Male candidates only
Food	Breakfast & Lunch provided by company
Transport	Company pickup & drop facility available from nearby locations (Penukonda, Dharmavaram, Anantapur, Putaparthi, Hindupur etc.)
Job Location	Penukonda, Anantapur district.
NEEM training Period	6 months to 36 months (Later to which people will be given an opportunity based on their performance and further testing)

In this regard, all the Principals of the Govt/Private polytechnics in the state are requested to give wide publicity regarding the training & opportunities at Kia India and furnish the details of interested students of Polytechnics in the attached excel sheet (soft copy and hard copy) to the District Coordinators/Nodal Principals of the respective Districts and the details of the TPO/In-charge of the program in the Google form.

The District Coordinators/ Nodal Principals of all the 13 Districts are requested to coordinate with the Principals of the Polytechnics for obtaining the details of the interested students and consolidate the received data from all the Govt./Private Polytechnics of the district and furnish the details to the T.P.O., O/o CTE, A.P, Vijayawada and the list will be forwarded to the Manager (HR & Admin), KIA, Ananthapuramu from this office.
