With reference to 1st cited above, instructions were already issued regarding CISCO training for CME and ECE branches as Industrial Training. In that it is clearly mentioned to dispense CISCO training for these branch students and to make Industry connect with the large Software/Hardware Companies. However certain Polytechnic colleges have not dispensed CISCO Training and even for second spell training also action plan proposals from Certain colleges included CISCO Training as six months Industrial Training. The deviation of instructions will not be allowed and CISCO Training as Industrial Training shall be dispensed and second spell action plan should reflect the same.

It is further informed that, in the reference to the 2nd cited above, already permission accorded regarding Industrial Training placement of students outside Andhra Pradesh State. The Polytechnics are solely responsible for their students attending Industrial Training outside the State and the Principles are instructed to obtain indemnity bond from parents and students. In addition to this, the hostel facility for students as well as providing stipend for students during Industrial Training shall also be addressed.

It is informed that as per Curriculum C-20, Diploma students of all Branches are to be sent for Industrial Training for 6 months in their V / VI semesters as per the schedule (spells) already communicated vide circular 3^{rd} cited.

Instructions were also issued to all the Principals and TPOs to meet the top-level management representatives of the industry and appraise the need for industry collaboration and also to explore the possibility of a tie-up with big Industries.

The present CISCO training for CME and ECE branches as industrial training shall be dispensed with and for these branch students, Industry Connect shall be made with large Software/ Hardware companies.

In this regard, the detailed Guidelines for Industrial Training for 2022-23 is prepared and given in the Annexure. All the Principals of Government and Private Polytechnics are instructed to communicate these guidelines among the stakeholders and follow them scrupulously.
